- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Pat Rodriguez, in conformance with the Wisconsin Open Meetings Law.
- 2. A roll call was conducted. A quorum was present.
- 3. The committee reviewed the current roster. Several members noted errors in their contact information.

Mr. Smith introduced two new Employer members: Leigh Emrick and Jim Bunkelman. Mr. Smith acknowledged that the Bureau overruled the state committee's previous motion to not award an additional seat to Associated Builders and Contractors.

Attendees did not have questions or comments.

#### 4. Action Items

#### a. Elect Employer Co-Chair

The state committee postponed the election until the 2022 spring meeting.

#### b. For action: approve the minutes

The minutes were approved as revised: the state committee requested that the minutes state, "the entire state committee disagreed."

#### c. Accepting proof of high school education or equivalency

Mr. Smith reported that the received a request to include this item on the agenda. The state committee agreed that the matter did not need to be discussed; it was resolved at the local level.

#### d. Minimum ACT Math score of 15

Mr. Smith reported that the Bureau will review state construction committees' statewide minimum scores this summer to ensure they are still helpful four years after they were implemented. He reviewed that the state committee established one statewide minimum score that local committees must follow: an ACT Math score of 15. All other assessments and scores are at the discretion of the local committee. He asked the state committee how the score has been working.

The state committee agreed to keep the current requirements; applicants that do not pass can take another assessment or receive additional support. In addition, local committees that use proprietary assessments also offer Next Generation.

#### 5. Discussion Items

#### a. BAS Director's Call with State Committees

Director Polk reviewed that the Bureau hosted the first virtual Director's Call this spring. The objective is to present updates that pertain to most or all state committees in a single forum so that each state committee's agenda is dedicated mostly to its unique program(s). The Director's Call was approved by the Wisconsin Apprenticeship Advisory Council at its first quarter meeting.

Director Polk emphasized that although the Director's Call is intended to streamline state committees' agendas, committees will be able to discuss items from the call at their respective meetings, if needed.

Director Polk asked attendees for feedback.

Attendees appreciated the streamlined format and the opportunity to hear from other state committees.

#### b. Modified format of state committee meetings

Director Polk and Mr. Smith explained that the meeting agenda is an example of the new format; the meeting is held in person, includes a virtual option, and focuses on the committee's unique policies.

Attendees did not have questions or comments.

#### c. Review of the Wisconsin Apprenticeship Manual

Director Polk reported that the *Manual* was reviewed by the Policy and Standards Subcommittee of the Wisconsin Apprenticeship Advisory Council and will be reviewed by the full Council on June 6. When the Council approves the revisions, they will become the official working draft and a 90-day public comment period will ensue. The Bureau will email links to the original version, the revised version, and a summary of changes to all state committees. After the 90-day period, BAS and the Council will approve the final version.

#### The state committee requested a list of Council members and inquired into its structure.

Mr. Smith stated that the structure and roster are posted on the BAS website. Mr. Polk reiterated that all meetings of the Council and its subcommittees are public and posted on the BAS website.

#### d. Review of state standards

Mr. Smith explained that the *Manual* provides the boilerplate language that constitutes 90% of the state committee's standards. Therefore, once the *Manual* is approved, the Bureau will populate the revisions into the standards. The revisions will include clarifications and new formatting, but not new policies. He reiterated that the committee's unique policies, such as its learning content, will not be affected and are at the committee's discretion.

Attendees did not have questions or comments.

#### e. Other

Several Employee members voiced concern that the roster insufficiently represents union contractor organizations active in apprenticeship. In addition, the members voiced concerned that the Carpenter apprenticeship is not represented on the WI Apprenticeship Advisory Council.

A lengthy discussion followed. Mr. Smith stated that if a contractor organization believes it is not represented on the state committee or Council, it can email an official letter of concerns to the Bureau, and the Bureau will research whether an appropriate seat is available. Mr. Smith and Director Polk also emphasized that state committees and the Council are representative, not all-inclusive. Both have maximum sizes and criteria for representation. Importantly, both advisory bodies are collaborative, not competitive.

Action: the Bureau will add expanding the size of the state committee to the fall agenda.
