Honorable Members of the State Disaster Medical Advisory Committee Vaccine Subcommittee,

Thank you for the opportunity to provide comment on the proposed recommendations for vaccine priority subgroup 1b. Public trust in the vaccine is of the utmost importance, and the transparent and methodical process you have used to create your recommendations is vital to building that public trust.

First and foremost, we are writing to thank you for including in your proposed 1b recommendation individuals in congregate living facilities. As you aware, the science, feasibility, and ethics of vaccinating this group of individuals in congregate living strongly weighs toward including them in phase 1b. Vaccinating residents of these facilities at the same time as the frontline staff will significantly reduce workload on state and local health officials and vaccinators. This approach alleviates considerable health equity concerns as well—for example, though Black Wisconsinites make up only roughly 6% of our population, they represent about 42% of individuals in shelter settings.

Thus, we are also writing to encourage you to include individuals staying at shelters in the Phase 1b recommendation. The committee recently raised feasibility concerns about vaccinating people experiencing homelessness who may be staying in shelters, particularly when the available vaccines require two doses. Data from Milwaukee County and experts working to support people experiencing homelessness may help alleviate the committee's concerns about their inclusion in this phase. We offer the following considerations to include the shelter population and participants in related programs in vaccine priority Phase 1b.

First, the committee felt that a two-dose vaccine to a highly transient population made the feasibility of reaching this group difficult and that waiting for a one-dose option would be prudent. The assumptions about the transient nature of this population is not well supported by data from shelters in Milwaukee County. For example, during winter months, According to XX, 75% of individuals stay (in shelters?) for at least 22 days and 66% of individuals stay for at least 31 days – with a significant population there for at least 90 days. This drops to 58% and 51% of people staying at least 22 and 31 days, respectively, during summer months. Given that the second doses of the vaccine are given either 21 or 28 days after the first dose, a large majority of this vulnerable population could feasibly receive the full inoculation of a two-dose series during their shelter stay.

Second, from an ethical standpoint, even if some people only receive the first dose in the two-dose series, the vaccinated individual receives substantial protection against COVID-19: one dose of the Moderna vaccine can provide up to 80.2% protection, and Pfizer roughly 52%. Furthermore, people experiencing homelessness are very mobile throughout the community during the day, often using public transportation. Providing protection from COVID-19 as quickly as possible will mitigate risks to this vulnerable population and the community overall. While having a one-dose option would be ideal for most hard-to-reach populations, we do not

believe this should be justification for delaying vaccine availability to any resident of a congregate living facility, including homeless shelters.

An additional point that we would ask the committee to consider is that 2020 CARES money has allowed local governments and organizations in Milwaukee to place people experiencing homelessness in hotel rooms to alleviate risks of spreading COVID-19 in a shelter setting Without additional funding for local governments, this programming will end. While short-term funding exists through the 2021 CARES extension, local governments cannot support this option much longer without new funding. Therefore, the present time presents an important opportunity to reach highly vulnerable individuals for vaccinations who would otherwise be in a shelter setting. We see that people stay at hotels longer, as well: 76% of individuals stay at least 31 days and 92% stay at least 22 days, making feasibility of fully inoculating people even higher. While these people are not currently living in a congregate setting, given the distinct opportunity afforded by the 2020 CARES extension to reach this population at hotels, we ask that the committee include people experiencing homelessness living in shelters or hotels in Phase 1b.

Finally, we wholeheartedly support the inclusion of all Family Care, IRIS, Wisconsin Partnership and PACE recipients in Phase 1b. Appendix C of the proposed recommendation explicitly states Family Care or IRIS recipients; however, individuals receiving care Wisconsin Partnership and PACE have many of the same comorbidity and other concerns identified by the committee. These individuals require nursing home level of care, and would otherwise be receiving care in a congregate setting were it not for this community-based program. We urge their explicit inclusion in Phase 1b, in addition to Family Care and IRIS members, to ensure that these high-need residents are not left out based on their participation in these programs.

We thank you once again for the service you are providing the people of the State of Wisconsin. Making such monumental decisions as these, particularly in the current life-or-death circumstances, requires significant moral fortitude. Please do not hesitate to reach out for further statistics or on-the-ground anecdotal evidence that would help inform your process.

I'm treated by the best at Children's Milwaukee and since March, haven't had any semblance of life because of COVID and being high risk.

After reading the proposed allocations, I'm sorry but you've got to be kidding me that we're vaccinating PRISONERS over those under 65 that are high risk with severe medical conditions. We haven't been able to lead any semblance of a normal life since March. I'm all for vaccinating the guards and staff but those prisoners made the choice to be jailed.

I can't stress how much the pandemic has hit me and those under 65. We're stressed, causing more medical problems, have lost jobs since we can't work in the public anymore (myself included), and have to totally isolate and cut ourselves off. My entire family works in the health care and on the front lines and I haven't seen them since May. That's almost a year because I'm high risk. So when I see that those under 65 who are high risk aren't even INCLUDED in this next round, I was appalled and in tears. Your in essence killing those who might get sick by pushing us off.

The majority of teachers and grocers other essential works are healthy individuals (and most grocers are under 25 years old) who have a high rate of bouncing back if they catch it. Half are working from home such as Milwaukee Public Schools and Green Bay School District. If those high risk under 65 catch it, its a death sentence. Those are the people at the bars and family gatherings not even listening. Even the CDC included us in the next round so why aren't you listening to the scientists instead you, a politician. You have delayed the rollout and this should have been set months ago.



I'm very disappointed with the potential groups that may be added to 1b. The limited vaccine should be prioritized to those who are at highest risk of poor outcomes. Period. Save lives!! (The prioritization of vaccine during H1N1 was children as they were most vulnerable to it.) The same should be done here. After 70 year olds it should be offered to those 65 and up and to those under 65 with conditions that put them at highest risk for poor outcomes. These are the people living in absolute fear of the virus everytime they have to go out or get a delivery. These are the people who end up in the hospital. These are the people dying!! These are the people that need to get the vaccine first. The overall goal at this point needs to be preventing morbidity and mortality and decreasing the burden on hospitals and staff.

It appears to me that the intention of the groups listed is more about convenience than solving the problem and saving lives. When I say convenience I mean that just because people are confined (and may have access to staff able to vaccinate) does NOT mean that they are at risk of poor outcomes. If you vaccinate correctional officers then the likelihood of spread to inmates is low and they are not out among the general population. Inmate's SHOULD NOT be prioritized over others at-risk for many reasons.

Teacher's at risk of poor outcomes should be offered the vaccine (again if they are prioritized with 65 and older/under 65 and high risk they would be covered). That doesn't mean ALL teachera should be offered the vaccine now. Again, you appear to be looking at convenience over need.

Its pretty simple really. There should be a state wide link to guide you where to sign up and it should all be clear and simple. All counties have mass vaccination plans in place. Best practice would be by appointment, drive through vaccine clinics either done by pharmacies or a combined effort. (Health departments are way too busy doing contract tracing.) WI appears to be sorely lacking in its response and readiness for vaccine distribution. Other states are doing way better!



I am a 67 year old in Dane County. I provide 25 hours of child care to my daughter's children as both parents work full time. I fully appreciate the difficulty of deciding priorities, but I am, along with others in my age group, at increased risk of exposure as one of the children will be returning to inclass instruction in three weeks (as per Middleton School reopening plans). Moreover, my daughter is pregnant and in a high risk pregnancy group.

In most other states, I would be able to get vaccinated due to my age and the child care I can provide. My daughter would also receive a vaccine. In Wisconsin, we are at high risk of severe illness and death, yet we do not even have a date for a vaccination. How is this possible? 

Phase 1b Draft Comments:

I urge you, in the strongest possible terms, to place people age 65 years-old and older as the highest priority in phase 1b of the Covid vaccine distribution plan.

I am 69 years-old, and my wife and I have listened to the infectious disease experts and followed the safety protocols. For almost a year, we have listened to such health experts tell us that we are at highest risk of serious illness and death from Covid-19. We have followed all of their recommended safety protocols, avoided stores and even utilized curbside pickup for our groceries. But now, when the vaccine if finally arriving, we find out that we are placed behind much younger mink farmers, teachers, and prisoners in the distribution plan. WHAT!!!!! While I certainly understand the reasoning for including these groups as a higher priority than the general public, to place these groups ahead of the elderly is unconscionable. Even if young people in these groups get infected, they are much more likely to have a mild form of the disease. Many younger people in our community have become infected and have had no symptoms or very mild symptoms. I understand the need to protect prisoners in confined settings and to vaccinate teachers to get students back to school, but to sacrifice the lives of elderly residents to achieve these objectives is not reasonable.

It makes sense to now place residents aged 65 years and older as the highest priority to receive the vaccine. Seniors have a high degree of vaccine acceptance while younger individuals in other groups are more adverse to vaccines. This is important from a purely public relations perspective. Phase 1a included health care professionals and people in long term care facilities, and is now expanding to law enforcement officers. But so far, this effort has been a very anemic as a small percentage of the vaccine already delivered has been administered. It has been almost a month since the first vaccine was received in Wisconsin and the hospitals have been administering the vaccine at a snail's pace while the elderly have been eagerly waiting for it.

The draft for phase 1b calls for seniors aged 70 and older to be included with other groups. I understand that the higher a person's age, the greater risk of death but why was such an arbitrary number used? The CDC and federal partners identify the elderly over the age of 65 as the highest priority group. Federal authorities just stated that the remaining doses of the vaccine will be released to the states and recommended that people over the age of 65 be given the highest priority. It is confusing and makes the elderly more cautious giving such mixed signals... first it is 65, now it is 70. Consistency in message will be rewarded in greater vaccine acceptance. The state of Florida began with the elderly and many other states have followed, so they are way ahead of Wisconsin in taking care of their elderly population. All of the publications we've read and infectious disease specialists we've listened to always refer to those over the age of 65. And now at the last minute, Wisconsin authorities want to change that narrative.

Public confidence in the vaccine has wained given the sad pace of vaccine administration. Wisconsin now needs a successful rollout to boost confidence. If you identify seniors over the age of 65 as the next group to receive the vaccine, you will find an eager and accepting group ready for vaccination. Once you have a successful inoculations program for the elderly, confidence in the vaccine will balloon. People will see that is is safe and effective, and they will be more accepting. I assure you, a successful vaccination program for the elderly will make phase 1c and beyond much more successful. After all, the objective is to vaccinate as much of the population as possible, and starting with the elderly is the fastest way to achieve that.


While the committee members putting the distribution plan together may be laser focused on technical issues, you should definitely consider community acceptance and the larger picture. By minimizing the impact on the elderly and placing us behind other groups less at-risk, you are causing a negative perception which will ripple through the community and make mass vaccination almost impossible. So if your objective is to get as many Wisconsin residents vaccinated as possible, I urge you to start phase 1b with seniors over the age of 65.




