5. Updates for the Advisory Council

- a. Access and Outreach Subcommittee Update: Mental Health Training for Apprentices

Sub-committee recommendations to council:

- i. Propose that the WI Apprenticeship Advisory Council recommend mental health training for all apprentices and refer the item to the applicable state committees for additional discussion and potential action.
 - a. Subcommittee will create a resource sheet of available mental health training providers and programs for the Council to review, approve and distribute

The committee discussed the recommendation, including potential implementation approaches. They noted that allowing different industries to adopt the recommendation on varying timelines would support data collection and help identify best practices. The discussion also covered how training would qualify under the proposed approach.

The committee also inquired as to what additional outreach or data collection BAS could perform to determine what employers currently use for mental health training.

6. Wisconsin Technical College System (WTCS) Update

Chrystal Seeley Schreck provided an update on enrollment numbers, tools of the trade, and an overview of the joint BAS/WTCS meetings held in early September. She also discussed the apprenticeship curriculum review process.

7. Youth Apprenticeship (YA) Update

John Keckhaver presented the following updates:

- The YA consortium grant application season is approaching. There are currently 40 operating consortia, with 99% of public school districts participating.
- YA aims to increase participation from high schools within those districts, as well as from eligible private high schools.
- YA grant funding was temporarily increased in the 2025 (12.5million) –26 (13.5 million) state budget; however, this funding level is not guaranteed in the next budget cycle.
- YA is implementing a new five-year review cycle for all programs to support continuous improvement and quality assurance.

8. BAS Quality Assurance Division Update

CPA Update – Jesse Gitter provided a review of recent updates to the CPA program guide and application process. Jesse also reviewed employment rates of CPA completers and their applicable wage rates by quarter.

Programs – 41

Newly added programs – 4

Program reviews conducted – 2

Completers who entered into a registered apprenticeship between 1/1/25 and 9/30/25 – 152

Council also discussed examples of successful CPA programing that is currently in place in WI.

9. Grant Updates

Early Childhood Educator (ECE) Apprenticeship

Program growth in Northeast Wisconsin has led to the addition of NWTC as a third cohort sponsorship school.

Current grant funding is supporting an additional cohort of 16 apprentices at NWTC.

The three cohort schools are now – NWTC, MATC and CVTC

Teacher (K-9) Apprenticeship Pilot

The K-9 Teacher Apprenticeship Pilot is continuing with 8 active apprentices.

There are 5 sponsoring school partners, including one new partner: Dr. Howard Fuller Collegiate Academy.

UWW at Rock County has been added as a second related instruction provider.

Education Assistant Apprenticeship (In Development)

A new Education Assistant Apprenticeship is currently under development.

Expected launch date: January 5, 2026.

10. Other Topics from the Director or Council Members

Director Polk advised the council of WI reaching a new milestone of over 18,000 apprentice contracts.
