Minutes

1. Welcome and check-in

2. Review and approve minutes from 7/21/21 meeting

Andrea moved to approve the minutes. Janel seconded the motion. All members in favor; none opposed.

3. Ideation Phase: Continue discussion of recommendations and criteria

Andrea has started gathering ideas/recommendations by interviewing community stakeholders for input, so that it's representative of the local community voice. Her conversations with the community generally focused around the concept of "Upstreamism" – impacting health and well-being by dealing with issues upstream. Next, she plans to fill out the IDEATION worksheets using these ideas. So far, some ideas gathered are:

- WIC reform (specifically fruit juices for young children)
- Medical debt prevention/policy
- Minimum wage as a living wage
- Expansion of housing assistance and eviction protection
- Earned Income Tax Expansion
- Invest in early childhood education that culturally responsive
- Mental health coverage expansion
- Enhance policy around workforce discrimination

Enhance access and expand refugee resettlement services

Isaak is currently working with Barron County Housing Development to start a *housing project to address the housing shortage* issue considering the increase of immigration/refugee resettlement projected for fiscal year Oct 2021 – Sept 2022. The goal is to increase housing in Barron, but no targeted dates yet of when this will happen.

William shared ideas/recommendations related to the expansion of Medicaid coverage and making health services accessible to all who need it:

- Continuous BadgerCare+ coverage for all eligible children or children under 5 years old
- Expand Emergency Medical Assistance coverage for undocumented immigrants and childless adults
- Use Medicaid funds to help address Social Determinations of Health (e.g. transportation, housing, etc.)

Isaak added that working families who depend on continuous BC+ coverage end up losing coverage based on their earned income exceeding the BC+ income limit eligibility. How can we adjust the state BC+ household income eligibility criteria, so that parents can continue supporting their children/families by earning a living wage income and receive health coverage for the entire family?

Gale added that the BC+ program began as a waiver through the federal government (over 10+ years ago) centered around affordability and eligibility for the uninsured. She suggested all members review the waiver and then consider the idea of proposing a new waiver to expand Medicaid further to reach those currently without health coverage.

Review of timeframe and criteria for Ideation Phase and next steps:

Some members asked about how/who to submit their Ideation Worksheets, criteria to consider when completing Ideation Worksheets, and what the next steps will be.

 Beth provided clarification of the timeframes, guidance of criteria/feasibility of policy pathways, and process moving forward (i.e. the timeline for submitting ideas from communities, evaluating them, and then prioritizing them). This information is detailed in the CREATE Phase: Timeline and Structure" power point slide deck by Dr. Michelle Robinson, presented to the GHEC on 7/21/21.

A member asked how specific ideas should be (in terms of operational criteria and identified administrative pathways). For example, members have suggested some very specific ideas/policy recommendations (like service reimbursement rates) while other ideas are very broad (prevention programs, expansion of medical coverage, transportation, etc).

- Beth explained that during Ideation Phase, creativity is the most important thing. Proposals/ideas don't need to have all the details/be perfect but are more so responses to issues/challenges members identified during our meetings 7/21/21 and today. The end goal is for policy proposals/ideas moving forward be specific and actionable (i.e., detailing a concrete path to make a policy change).

4. Decision voting
