Re: SDMAC Phase 1b: Recommendations for Public Comment

Dear SDMAC- Vaccine Subcommittee Members,

United Migrant Opportunity Services/UMOS Inc. (UMOS) is a non-profit advocacy organization that provides programs and services which improve the employment, educational, health and housing opportunities of under-served populations, including Migrant and Seasonal Agricultural Workers (MSAW). UMOS currently operates 40+ programs with more than \$25 million grant and performance-based contracts from federal, state, and local funding sources throughout 7 states.

UMOS urges the SDMAC Vaccine Subcommittee to consider MSAW as Essential and prioritize them in Group 1b for Covid-19 vaccinations.

Wisconsin's MSAW are essential workers who ensure that the nation's food supply chain is not interrupted. This demographic is the core of the food supply chain and protecting them is vital to the nation's food security. Across the country, there are 2.4 million farmworkers, of which 1.3 million reside in states who are among the top 15 in the number of known Covid-19 cases.

Agriculture is Wisconsin's top economic driver, and this industry relies on a healthy and stable MSAW workforce. There are approximately 72,425 agricultural workers in Wisconsin. Out of over 500,000 Covid-19 cases in our state, a growing number are in the agricultural sector. As an organization with significant experience directly serving farmworker communities in Wisconsin, UMOS is concerned that the effect of Covid-19 on the working, housing and transportation conditions of farmworkers have serious implications for agricultural communities and our food supply. The MSAW population is extremely vulnerable to Covid-19 transmission due to both congregate living and working in close quarters. Their essential work puts their lives and, by extension, the communities they work in, at risk.

Furthermore, MSAW are primarily Hispanic or Latinx, a population disproportionately impacted by Covid-19. The most recent WI data from DHS indicates that Hispanic or Latinx patients have 1.7 times greater case rates compared to White Wisconsin residents. Latinx patients also have the highest case rate at a little over 13,000 per 100,000 people.

UMOS respectfully disagrees with the comments in Appendix B regarding the low probability of addressing logistical challenges to vaccinate agricultural workers in employer-sponsored housing. Failure to prioritize MSAW in Group 1b runs counter to the Vaccine Distribution Sub-Committee's stated goal of addressing health inequities and disparities, as well as running counter to what the ACIP and CDC have recommended.

UMOS urges the Sub-Committee to include Migrant and Seasonal Agricultural Workers as the essential workers that they are, and strongly recommend including them as a priority in Group 1b, as other states have done. Any other direction demonstrates a grave injustice to this vulnerable population that is counted upon to ensure the stability of our state's and nation's food supply.

[The River Food Pantry](#) is South Central Wisconsin's **busiest food pantry**, serving over 1,000 households every single week. **Hunger-relief frontline workers and volunteers, like ours, must be included in the Phase 1B recommendation for the COVID-19 vaccine to ensure the record number of food-insecure children, seniors, veterans and families receive the food they need to survive this pandemic.**

In 2020, 15,381 people—one third of which are children—relied on The River for free weekly groceries, daily meals and other essentials, including masks, cleaning supplies, personal hygiene items and paper products, to stay healthy and safe. In response to COVID-19, The River continues to serve more first-time visitors than ever before. **Since the pandemic began, over 2,500 new families have registered for our services**—a 60% increase compared to before the pandemic.

With a spike in demand, [in 2020](#) The River served a record-setting 3.7 million pounds of food to 6,063 households, saving the average family \$210 per visit to spend on other expenses during this economic crisis.

To safely meet the growing nutritional needs of Dane County throughout the pandemic, The River increased our hours of distribution and adapted all of our programs to include free curbside groceries, mobile lunches for children, to-go meals for families, deliveries to the homebound, and (coming soon) an online marketplace.

With 16 full-time and 4 part-time staff to oversee longer distribution hours, The River heavily depends on volunteers to run our growing list of programs. **However, the health and safety restrictions of the pandemic have slashed our volunteer base. In 2020, we received 50% less volunteers and service hours than the prior year.** *Imagine how many more mouths we could feed if we had more safe and healthy bodies to do it!*

**The sooner hunger-relief frontline workers and volunteers receive the vaccine, the more we can do to solve rising hunger in Dane County.**

Dear Wisconsin State Disaster Medical Advisory Committee Vaccine Subcommittee,

Thank you for your efforts to ensure efficient and equitable distribution of vaccines. It is incredibly important and necessary that the Phase 1B recommendation for the COVID-19 vaccine include hunger-relief frontline workers and volunteers. These workers and volunteers are essential to continue the unprecedented distribution of food to those Wisconsinites experiencing hunger during the pandemic and economic crisis.

Prioritization of hunger-relief frontline workers is imperative for the following reasons:

- Hunger-relief workers and volunteers are the critical force behind the wellbeing of the record number of Wisconsinites facing food insecurity. One in eight Wisconsinites, including one in five Wisconsin kids, don't know where their next meal is coming from. The hunger-relief network is mobilized like never before to meet this need. Our network is serving about 60% more individuals than last year. And Wisconsin's Feeding America member food banks and partners distributed about 90 million unprecedented pounds of food to those experiencing food insecurity from March to September of 2020, that is 25 million more pounds than was distributed in all of fiscal year 2019.
- The hunger-relief frontline workers and volunteers serve individuals in vulnerable health situations. People experiencing food insecurity have a disproportionately high rate of chronic health conditions that put people at higher risk of severe COVID-19 complications. This population frequently has less access to consistent quality health care and insurance. Also, 23% of households served has at least one senior and we know that age is a good indicator for risk of severe COVID-19 complications or death. People of color disproportionately experience food insecurity and are also known to be at greater risk of severe COVID-19 complications.
- It is our duty to ensure the safety of those being served. Individuals being served and in contact with hunger-relief frontline workers have few other options but to seek assistance from food pantries and meal sites do not have a way to mitigate their COVID-19 risk. They cannot avoid the interaction with staff and volunteers and rely on the organization to help meet basic needs and provide them with the meals they need to live.
- The hunger-relief network relies heavily on volunteers to fulfill the mission, many (37%) of these volunteers are seniors. An estimated 52 percent of food pantries and meal sites report having no paid staff. Among the 46 percent of agencies with paid staff, the median number of paid full-time equivalent staff members reported is four. As a result, if staff or volunteers were to test positive for COVID-19 and potentially require other staff or volunteers to quarantine, food distribution operations would be greatly impacted.

Collaboration between our hunger-relief organizations, public health, and those administering the vaccine will be essential to planning for equitable and efficient distribution, addressing concerns, educating about and adhering to appropriate protocols.

The COVID-19 vaccine is a critical step toward ensuring the safety and health of staff, volunteers, and those accessing food resources. It also ensures that food banks have the capacity to continue distributions at this unprecedented rate to feed Wisconsinites experiencing hunger. Thank you for your consideration.

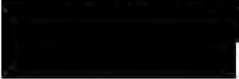

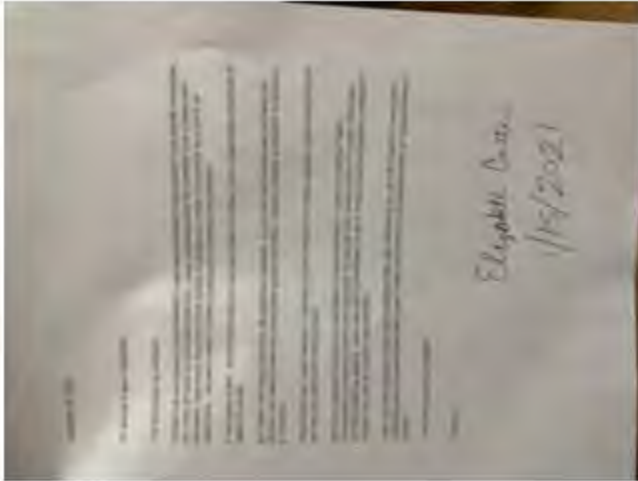

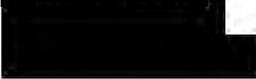

Grocery workers have worked tirelessly throughout the pandemic and are as critical to our food supply as farmers. While our company takes every safety precaution possible for our team, the reality is that this team has been exposed to the members of the public every day and put at increased risk of infection for nearly a year now. Even with capacity limits in place, our team of 150 employees is exposed to 2,500-3,500 customers each & every day at each of our (3) locations.

Good morning,

Wisconsin's Safer At Home order went into effect on March 25, 2020. The goal of the order was to prohibit nonessential travel and limit gatherings to help flatten the curve of COVID-19 and ensure capacity of Wisconsin's health care system.

There were three industries noted in that order as being reasons to leave your home: Healthcare, Pharmacy and **Grocery (Food and Supplies)**.

As the leader of an Organization that employs over 530 employees that **provides over 130,000 cases of food and supplies**, including dry goods, cleaning products, paper products, meat, dairy, produce and frozen food to independent grocery stores around our state of Wisconsin **EVERY DAY**, I was so disheartened to share the news that our industry was moved down the list for potential COVID-19 vaccine with my employees.

I understand this committee is made up of many front-line heroes that were beyond critical and essential over the past 10 months, and you are more than deserving of the vaccine, I 100% support that direction. I agree with everyone that was in the Group 1A, they all need it more than the rest of us.

However, your recommendations of persons to be included in Group 1B I do not believe make sense. On October 29, 2020, the CDC published the "COVID-19 Vaccination Program Interim Playbook for Jurisdiction Operations". Their definition of Phase 1B was as follows: "People who play a key role in keeping essential functions of society running and cannot socially distance in the workplace (e.g....**food** packaging and **distribution workers**..."

As I read your "DMAC VDS Phase 1b Recommendations FOR PUBLIC COMMENT" document and review your idea of public-facing essential workers, you are considering:

- Persons in the back office of healthcare organizations, who I'm assuming can and have been doing their work remotely
- Mink Husbandry; the last I checked I have not seen mink running around the State of Wisconsin freely and persons constantly infected
- Incarcerated individuals; last I checked these are criminals, they are locked up, NOT IN PUBLIC EVERY DAY. Note, I do agree with vaccinating the guards and personnel that put themselves at risk daily.

How in the world do the above groups of people meet that definition of public facing or essential functions for society? And in the meantime, you read what the CDC gave very early on, and you are completely ignoring a critical group of true front-line public facing people.

If grocery stores have to close due to mass COVID-19 outbreaks, you are talking about almost every



living person in our State having an immediate problem, food and supplies. We are part of what is keeping “an essential function of society running”, and social distancing at all times is a challenge.

Next, I try to consider in your rationale, perhaps they are unsure on how to reach those of us in the grocery and food supply industry and that is why they pushed us down the list?

As I stated in my business description, we are lucky to partner with stores across the state of Wisconsin, and the stores we service are the owners of Certco, Inc. We have three massive campuses in the Madison area, and we service all Woodmans Food Markets, whom I know also have opened up their campuses to leaders in charge of vaccine distribution; we also service Sendik’s Food Markets in the Milwaukee area. If you provide a pharmacy partner, many of us utilize Walgreens to provide our employees with onsite flu shots every Fall, we will get you the masses of people. 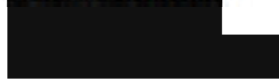
