On behalf of the Wisconsin Partnership, I'm writing to support the inclusion of child care educators in vaccine priority group 1b as proposed in the SDMAC VDS Phase 1b Public Recommendations.

The Wisconsin Partnership is a collaboration of four local collective impact partnerships in the state: Achieve Brown County, Building Our Future in Kenosha County, Higher Expectations for Racine County, and Milwaukee Succeeds. Collectively our communities serve one in four Wisconsinites between birth and age 8, including 80 percent of Black children, 46 percent of Latinx children, and 41 percent of children in low-income families. Our goal is to promote policies and practices that expand access to quality, affordable early childhood education in our communities and statewide.

COVID-19 has placed profound stress on the child care sector. Child care programs face declining revenue, increased expenses for PPE and cleaning supplies, and serious health and safety concerns. Yet even at the height of COVID-related shut downs during the spring of 2020, the majority of Wisconsin child care programs heeded Governor Evers' call and stayed open to provide care for the children of essential workers. Now almost all Wisconsin child care programs are open, and in addition to serving our community's youngest children, many are also providing a safe space for school-age children to participate in virtual instruction while K12 schools are closed to in-person learning.

As noted in Appendix E of the Recommendations, child care settings by definition require face-to-face contact between educators and children. Inclusion in priority group 1b will allow child care educators to more safely do their vital work of keeping children safe, cared for, and supported which in turn allows parents to participate in the workforce. Thus, vaccinating child care educators will have a significant positive impact on the social and economic wellbeing of families and the community as a whole.

Thank you for your work to ensure fair, equitable, and effective distribution of the vaccine, and for your commitment to Wisconsin's children, working parents, and businesses.

I wanted to share my appreciation that childcare workers are being included in group IB. So often, those of us in early childhood are forgotten about. It's always K12, without thought to the preschool years. In this case, I think it's really important to remember that we have been open, in person, throughout the pandemic, providing programming. Our teachers interact with up to 32 different families every day, and we don't have the option of doing at-home virtual learning with 3 year-olds whose parents need child care.

We've had a small number of children in our program test positive, and when that happens, the entire class has had to shut down and quarantine for two weeks. That includes teachers, who then can't teach their other classes. This has a ripple out effect that impacts large numbers of families. So, the sooner this group of early childhood teachers is vaccinated, the better.

I mostly wanted to point out that the majority of early child care programs in Milwaukee don't have their own nurses, and so we'll need to know how and where to go — or would need health department teams to come to us. I think most K12 schools have the advantage over us when it comes to having medically trained personnel on staff.

Thank you. Kudos for working to get this done quickly and effectively!

#### Dear SDMAC,

I would like to submit this written feedback for the Vaccine Allocation in support of our early childhood education substitutes (essential workers) who work at child care/daycare programs across the cities of Milwaukee and Madison, Wisconsin.

- Teachers On Call employees (substitutes) work in partnering DCF licensed child care facilities alongside the "daycare workers" outlined in phase 1b. The age groups that our substitutes work with are ages 0-5; an age group that is especially vulnerable to the spread of infectious diseases due to the close proximity of staff and students in centers.
- Substitute child care workers are essential to the economy they provide support to the child care centers when their own teachers are out sick, on leave or they are having trouble hiring. Without our substitute staff, child care facilities would have to shut down and are shutting down because they are understaffed. Child care centers shutting down leads to a decrease in care options for parents who rely on child care so they are able to work. We need to offer protection for child care workers so they do not leave the industry. Without child care or the child care workers, parents will not be able to return to work which will ultimately affect the workforce and many employers. We need to offer these essential child care workers the protection of a vaccine so they feel confident and safe working in this close environment.
- Without our employees some of our partnering child care centers would shut down temporarily, potentially permanently. We have received this actual verbalized feedback from some of our clients.
- The way we operate as a company, our staff have the convenience to travel from center to center. Travelling as a substitute, although necessary, increases the risk of COVID-19 spread.
   This vaccine would protect our employees and reduce the spread, therefore allowing our staff to be placed on more short-term shifts vs long term. This will help more centers in the long run by having additional short-term temporary help when needed.
- Many centers are also short staffed due to the child care crisis introducing new staff to their center by way of substituting could eventually lead to a permanent placement for a center enhancing the center's employee retention.
- We need to offer protection for child care workers so they do not leave the industry. Without child care or the child care workers, parents will not be able to return to work which will ultimately affect the workforce and many employers. We need to offer these essential child care workers the protection of a vaccine so they feel confident and safe working in this close environment.

I am a "family" (unregulated) child care provider in the Madison community since 2012. I do not work at a child care facility; I provide daycare in my own home. I am not licensed or certified - I operate within the statutes that govern this type of care - so I am not registered with authorities other than through my taxes. I am curious HOW (not when) you will be providing opportunity for providers like me to get the COVID vaccine when appropriate within phase 1B. Will we be able to produce taxes or some other "proof" that we are in the group? Can we coordinate with our local school or some other community site that will have a vaccination provider on site? I would like to challenge you to make sure the hours are compatible with the schedules of child care providers many of us begin work on weekdays before 8 am and have kids until almost 6 pm. Is there a plan for this? I'm aware and I'm ready to be very proactive about accessing this, I just want to make sure there will be adequate doses and a plan at some location.

I have been informed by two different agencies that we still aren't very far into phase 1A, and believe me, I GET IT. I am the parent of a child in the 4K Verona program and a 6 month old that will be starting daycare in April. I also work as an academic advisor (official title: student services coordinator) at the University of Wisconsin-Madison. I am writing this email to express strong support for including educators & support staff with direct student interaction (daycare workers, preschool teachers, K-12 teachers, long term substitutes, bus drivers, and building/support staff, faculty and staff in higher education that have direct student contact ) in the 1B phase.

My daughter has been in-person since July and her 4K program has done a tremendous job at keeping everyone healthy, but I still worry for the safety of her and everyone there. In Verona and in surrounding areas, there is a strong push to send all the kids back to in-person instruction. As a parent, it makes me nervous doing so without vaccinating our teachers and K-12 staff. I think if we want to get kids back to school, then we need to prioritize these groups in the vaccine rollout.

As for higher ed, I strongly support prioritizing those with direct student contact that have to be on campuses right now (faculty/staff teaching in-person, residence life staff, building/facilities managers that work in high trafficked buildings or residence halls, medical support staff). 
