IV. Assistive Technology Program Updates

Monica Smith from DHS shared that she has accepted the Telecommunication Assistance Program (TAP) Coordinator position. She gave an overview of the TAP program and shared an update on the TAP database.

- Andrea Bertone from the Department of Public Instruction (DPI) shared that she is trying
 to increase interest in assistive technology at the department level. She is working on
 updates to the DPI website. There was a recorded Assistive Technology 101
 presentation done by Paula Walser for DPI staff.
- Bill Maudlin from the Public Service Commission shared that an updated equipment list and vendor guidelines are forthcoming for the Telecommunications Equipment Purchase Program (TEPP). The new equipment list will emphasize distance communication.
- Scott Gilbertson from the Office for the Blind and Visually Impaired shared that they are now fully staffed. He meets with consumers in their homes and assists with training and technology to help people who are blind or visually impaired live independently
- Rich Skerbitz from North Country Independent Living shared that they will be moving to a new location. There will be an open house on June 16, 2020.
- Shar Brunes from Access to Independence shared that they are doing an inventory of their assistive technology devices. They have also set up a Valentine's Day display of assistive technology. Shar will send the pictures of the display for posting on the ATAC Facebook page. See Action Item 1.
- Jason Ostrowski shared that he is personally testing a smart controller for Samsung with his wheelchair.
- Jessica Holton from Division of Vocation Rehabilitation (DVR) shared that a new training
 officer will be starting soon. There is a new director for Workforce Development Area 10
 (Madison). DVR is also hiring a data analyst. The DVR AsTech team continues to meet.
- Ashley Walker from TMG did not have updates related to TMG, but did share that she is working part-time for Rehabilitation Engineering and Assistive Technology Society of North America (RESNA) to conduct trainings for the Assistive Technology Professional (ATP) certification prep course.
- Jenesis Lindbo from Center for Independent Living of Western Wisconsin (CILWW) shared that there will be an adaptive gaming event on June 17, 2020 and CILWW is celebrating their 40th anniversary on September 19, 2020.
