Julie Lewis, R.N. – Requesting Reduction in Screens, Termination of AODA, Termination of Home Health and Assisted Living Settings, and Access to Controlled Substances

Cheryl Streeter moved, seconded by Luann Skarlupka, to grant the request of Julie Lewis for reduction in screens to 14 urine tests and 1 hair test per year while she is not working as a nurse; when she obtains employment as a nurse the screens will be increased to 36 urine tests per year and 0 hair tests. The Board defers to the treater to determine if AODA treatment is still required. The Board denies the request for the ability to work in home health and assisted living settings, and access to controlled substances. **Reason for Denial:** Insufficient time under the Board Order (10/19/16) to demonstrate adequate compliance. Motion carried unanimously.

Melissa Owens, R.N. – Requesting Reduction in Drug Screens to At Least One-Half and No More Than 1 Hair Test Annually, Reduction of Daily Check-Ins, Termination of C.21 and C.22 When Not Applying to Jobs Listed in C.23 and Hospital Setting

MOTION:

Luann Skarlupka moved, seconded by Jennifer Eklof, to grant the request of Melissa Owens for reduction in drug screens to 14 urine tests and 1 hair test annually; when she obtains employment under her license, the screens will increase to 36 urine tests and 0 hair tests per year. The Board denies the request for a reduction of daily check-ins and termination of C.21 and C.22 when not applying to jobs listed in C.23 and hospital setting. **Reason for Denial:** Insufficient time under the Board Order (10/8/2015) to demonstrate adequate compliance. Motion carried unanimously.
