- 1. The meeting was called to order at 10:05 a.m. by Co-Chair Don Allen in conformity with the Wisconsin Open Meeting Law.
- 2. Attendance was recorded. A quorum was present.
- 3. The committee reviewed the current roster. No changes were needed.
- 4. Action Items

# a. Approve the minutes.

The state committee approved the minutes as revised: Mike Pohlman and Greg Young were present.

# b. Review the math requirements for applicants.

Mr. Cook stated he has a report for the committee but is not prepared to make a motion. The work group did not conclude its review and recommendations. The current objective of the project is to identify or develop a course as rigorous as ModuMath. However, technical colleges and industry disagree on whether the rigor of the course: technical college instructors assert it does not need to rigorous; industry prefers the course be as rigorous as ModuMath.

The work group will hold one more meeting soon. If consensus cannot be reached, industry will proceed with a recommendation to the state committee at the 2022 spring meeting.

# c. Approval of local apprenticeship committee via Northwoods Technical College

Director Johnson explained that the Bureau approved a new local committee, which is unaffiliated, through Northwoods Technical College. He stated the purpose of the agenda item is to inform the state committee of the new local committee, inform the state committee of the Bureau's decision, and to ask the state committee to support the new committee.

Director Johnson noted that he received many questions about the local committee prior to the meeting. He explained that any local committee that applies must due diligence through the Bureau's application procedure prior to the Bureau informing the state committee.

Representatives of the local committee provided an overview to attendees. Representatives included Jeff Jolma of Jolma Electric, Aliesha Crow and Erick Lockwood of Northwood Technical College. The presentation showed that the local committee's program meets the minimum standards set by the state committee, the Bureau, and the WTCS. The local committee has up to 13 contractors.

A lengthy discussion followed between the state committee, Director Johnson, and the Northwoods committee. The state committee expressed concern that it had not been involved earlier in the application process and asked several questions related to the local committee's administrative practices, e.g. selection procedures, curriculum, contractors, etc.

Director Johnson reiterated that the local committee followed all necessary administrative procedures, meets the established standards, and was approved by the Bureau. He noted that state committees are informed of new local committees but do not approve sponsors; that is the responsibility of the Bureau. Hasked the state committee to motion to approve the program.

**Action:** The state committee declined to make a motion of support, citing concern that they were being asked after the fact.

#### 5. Discussion Items

#### a. Mandatory registration in BASERS, effective July 1, 2021

The state committee reported that all local committees are registered in BASERS and register new contracts in BASERS.

#### b. Implementing revisions to CFR 29.30

Mr. Smith reported that BAS has begun quality assessment reviews with some local committees in the Milwaukee area.

#### c. Implementing Transition to Trainer and Teaching Transition to Trainer

Mr. Smith reviewed the WTCS website for the course, which includes the instructor requirements and calendar of upcoming courses. The state committee reported that its instructors for its local committees have either completed the required courses or are scheduled to take them in the fall or early 2022.

#### d. Supportive services and OJL reimbursement for registered apprentices

Mr. Smith reviewed the official correspondence and points of contact included in the meeting material. Attendees did not have questions or comments.

# e. Applicant outreach campaign and revisions to www.WisconsinApprenticeship.org

Mr. Smith reviewed the revised homepage and webpages dedicated to local committees. He encouraged local committees to email any revisions to him directly. Attendees did not have questions or comments.

# f. 2021 National Apprenticeship Week

Mr. Smith reviewed that the event will occur the following week. He encouraged attendees to notify BAS of any events they sponsor. Attendees did not have questions or comments.

# g. 2022 Biennial Apprenticeship Conference

Mr. Smith reported that the conference has been postponed indefinitely due to the pandemic. Attendees did not have questions or comments.
