- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Steve Brietlow in conformance with the Wisconsin open meeting laws.
- 2. Mr. Smith recorded attendance. A quorum was present.
- 3. The state committee noted that Dimitrius Thompson replaced Mike Busch on the Employee side. In addition, Doug Dokey will step down at the end of 2021; Trevor Martin will nominate a replacement.

## 4. Action Items

#### a. Approve the minutes.

The minutes were approved as revised: change the year to 2021.

- **b.** Continue or discontinue accepting TABE scores from applicants. The state committee approved discontinuing TABE scores as of November 1.
- c. Review state standards, including applicant assessments The state committee will begin reviewing its state standards once the Wisconsin Apprenticeship Advisory Council concludes its review of the *Wisconsin Apprenticeship Manual*.

### 5. Discussion Items

a. Mandatory registration in BASERS, effective July 1, 2021

The state committee reported that all local committees registered in BASERS and register all new contracts in BASERS.

The state committee recommended that training coordinators be granted access to BASERS rather than having to them request permission from the local committee. The Bureau will research the request.

The state committee reported that some BASERS authorized users cannot view information entered by previous authorized users. The Bureau is aware of this and is researching a solution.

## b. Implementing revisions to CFR 29.30

The Bureau began quality assessments with local committees in the Milwaukee area. The state committee asked whether the revisions will be included in the TAG sessions and whether TAG sessions will continue to be held. The Bureau confirmed the revisions will be included and sessions will be held.

## c. Implementing Transition to Trainer and Teaching Transition to Trainer

The calendar of required courses for new instructors is available online. The state committee reported that most local committees' instructors have been certified in the new curriculum.

## d. Supportive services and OJL reimbursement for registered apprentices

The Bureau reviewed the official letters and referred all questions to the official points of contact. Attendees did not have questions or comments.

## e. Applicant outreach campaign and revisions to www.WisconsinApprenticeship.org

The Bureau review the new homepage, which includes the campaign slogan and outreach video, as well as more user-friendly navigation. Attendees did not have questions or comments.

## f. 2021 National Apprenticeship Week

The Bureau reviewed the dates and encouraged sponsors and stakeholders to participate. Attendees did not have questions or comments.

## g. 2022 Biennial Apprenticeship Conference

The Bureau reported that the conference has been postponed indefinitely. Attendees did not have questions or comments.

## h. Apprenticeship Completion Award Program

The Bureau reported that the legislature renewed the program and increased the funding. Attendees did not have questions or comments.

## i. BAS leadership and personnel changes

The Director position is vacant. The position is projected to be posted soon and filled by 2022. Attendees did not have questions or comments.

## j. Other

The state committee noted that the blueprint examples on the journey worker licensing exam is copied over too much to be legible. The Bureau deferred to the Dept. of Safety and Professional Services.

The state committee reported that potential code updates have been proposed for spring 2023.

## 6. WTCS Update

Ms. Nancy Nakkoul reviewed the executive summary in the meeting material. Attendees did not have questions or comments.

# WTCS System-Wide Activity Update September 2021

### WTCS Apprenticeship Enrollment Trend

WTCS enrollments across all apprenticeship programs decreased from 7923 to 7630 unduplicated, and 8053 to 7720 duplicated, students by the end of 2020-2021 academic year. That is a 3.7% and 4.1% decrease, respectively, in one year.

## Ascendium Education Group Tools of the Trade Scholarships Increased Again in 2021

For the 2021-22 academic year, Ascendium Education Group has committed to awarding an additional 75 scholarships to industrial and construction sector apprentices who receive their related instruction through a WTCS college. A total of 325 awards of \$1500 apiece will be granted statewide in March 2022, with the scholarship application period open from late August until late November 2021.

MyWTCS is an intranet site for the Wisconsin Technical College System and stakeholders. Launched in February 2021, the re-designed site includes a new look and improved functionality and features, including an <u>expanded</u> <u>apprenticeship resources section</u>. WTCS systemwide publications, including the annual Apprenticeship Completion Report, can be found on the <u>Wistechcolleges</u> sister-site, under <u>publications</u>.

## Preparing to Teach Transition to Trainer (PT2TT2T)

MyWTCS also hosts information, administrative guidance, and upcoming PT2TT2T course offerings for instructors of the BAS-mandated apprentice Transition to Trainer course. As of January 2021, current instructors of Transition to Trainer must complete the 3-hour abridged Preparing to Teach Transition to Trainer course by the end of 2021.

#### New Proactive Approach to Revisions of Apprenticeship Related Instruction offered through the WTCS

Starting in 2021, the WTCS and BAS adopted a 5-year cycle revision framework for all systemwide apprenticeship curriculum where related instruction is offered at more than one WTCS college. Approximately sixty systemwide apprenticeship programs have a documented curriculum standard model that will form the foundation for review of program and course outcomes and competencies. Apprenticeship faculty, industry sponsors and State Apprenticeship Trade Advisory Committees will be engaged in the review process. This proactive approach will ensure that learning remains current with industry needs and technological advancements. Program assignment within the 5-year cycle will remain fluid.
