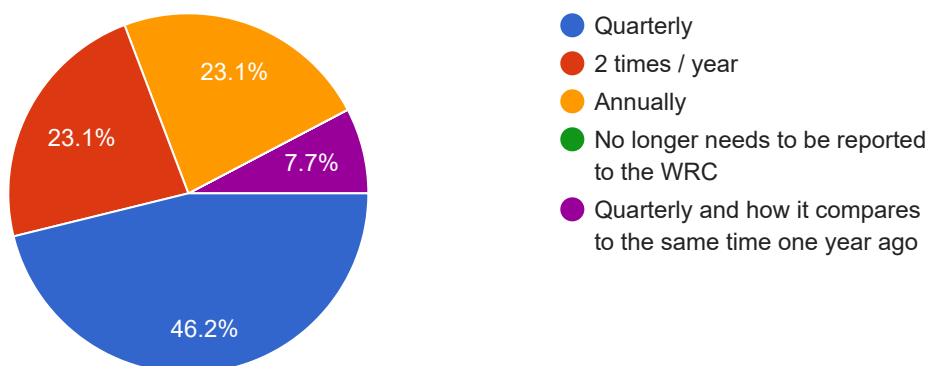

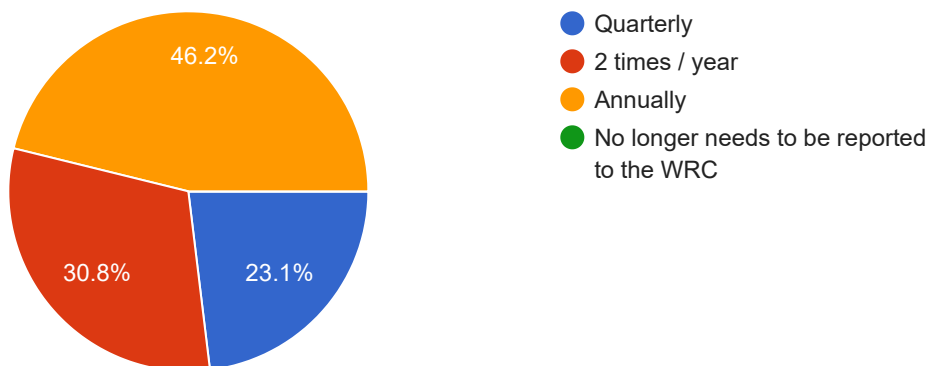
Program Year Outcomes: successful closures, wages, hours/week

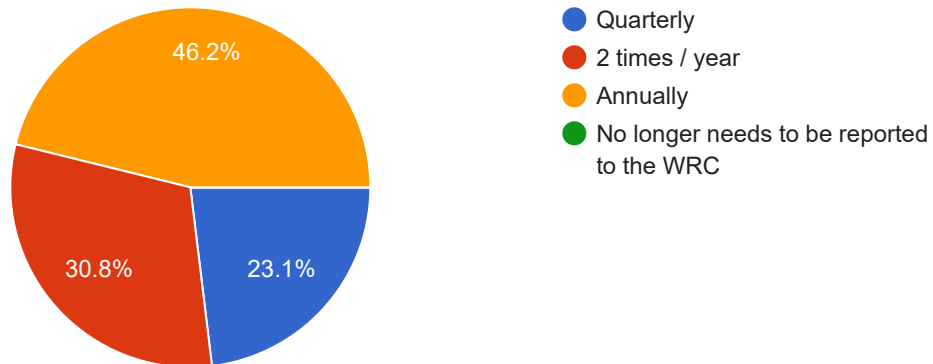
Program Year Outcomes: Q2 and Q4 post exit (including breakout for

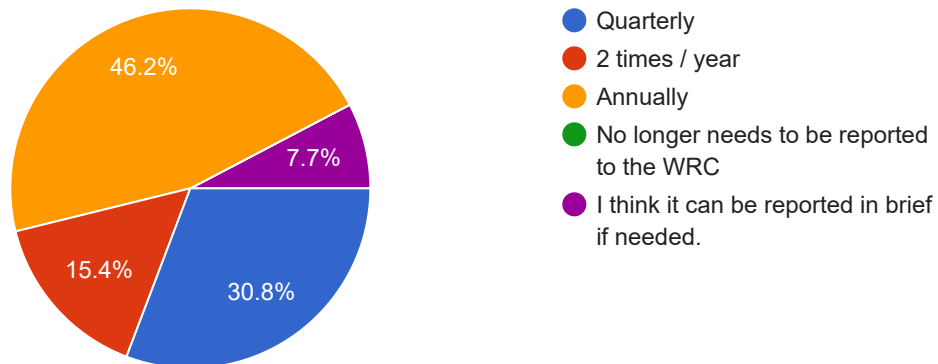

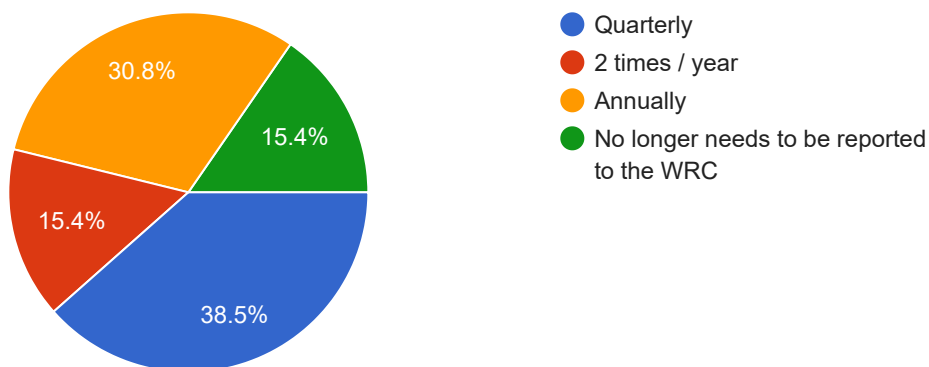
Referral Sources: 14(c) referrals by WDA

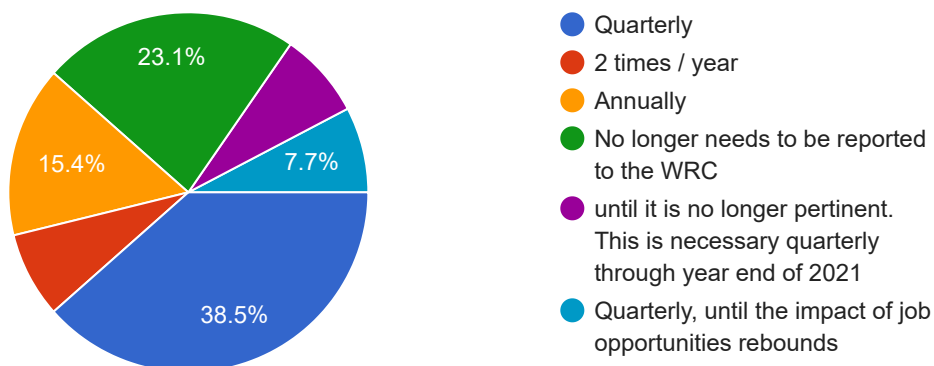

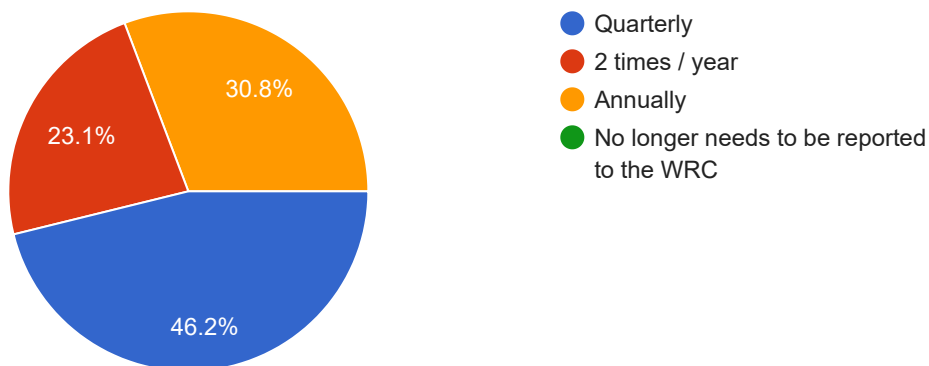
DVR COVID-19 Service Impacts: applications and eligibilities

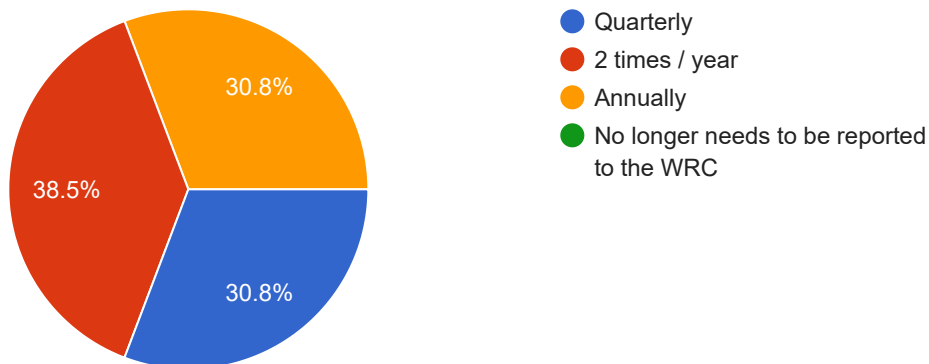
Federal Fiscal Year (FFY) DVR Budget : Total Budget and Total Spending

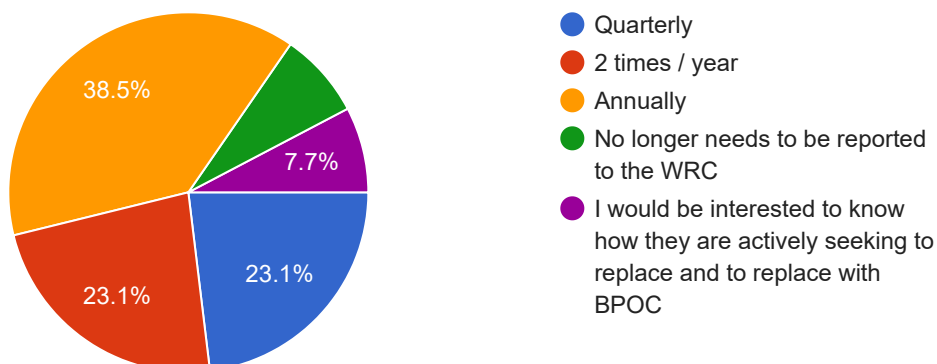

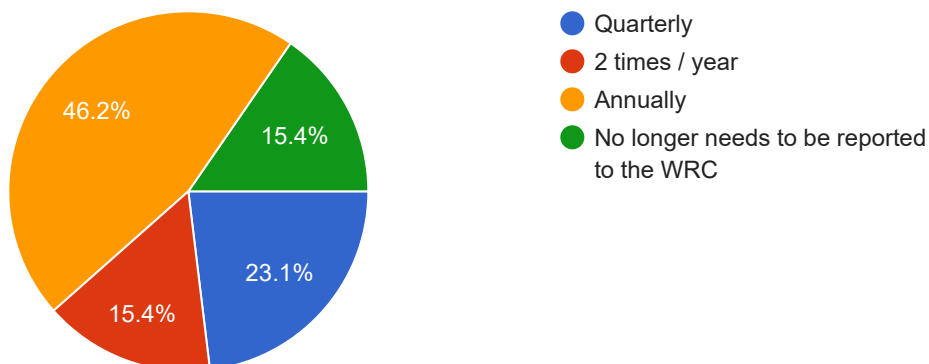

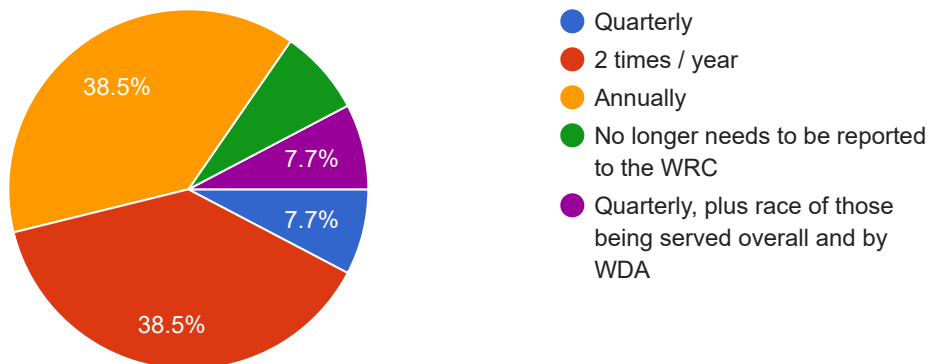

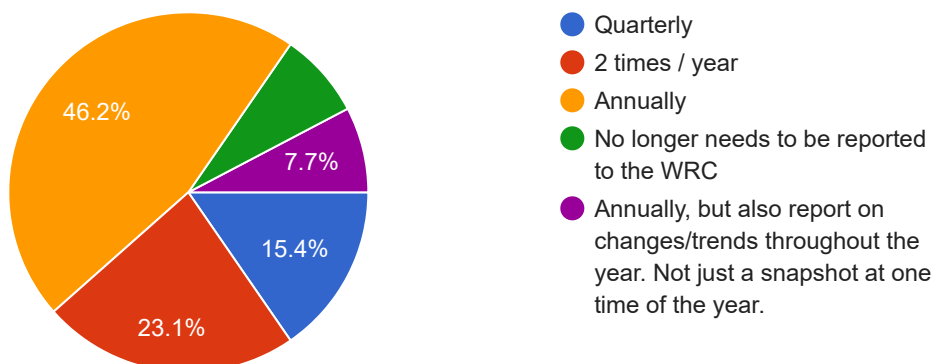
DVR Counselor Numbers by Race

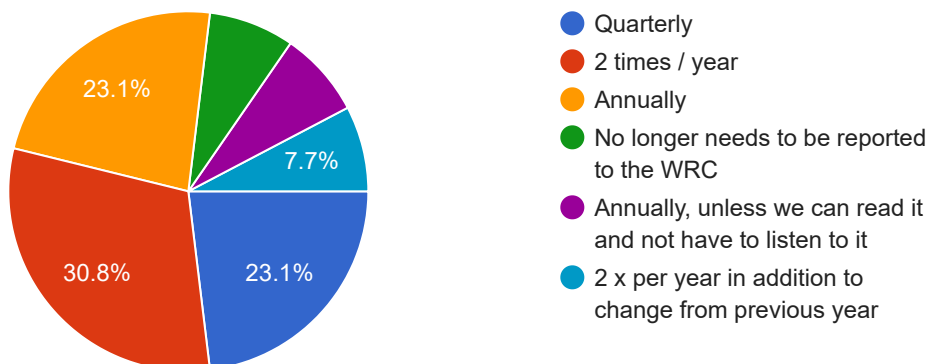
DVR Caseload for VRCs and VRs

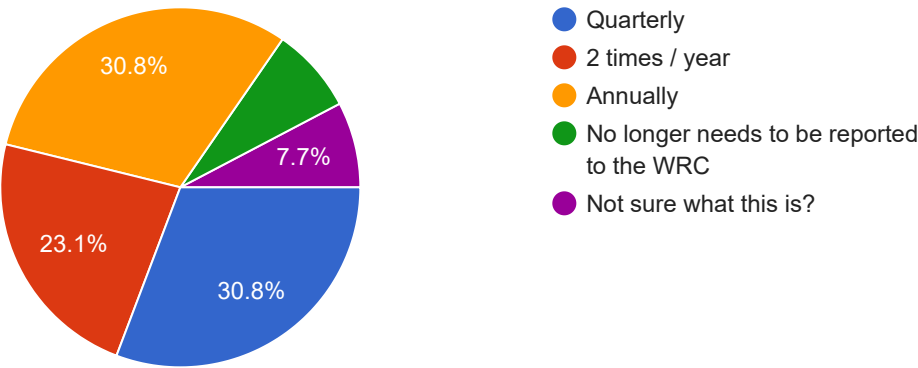
Case Review: including number of DVR cases by case type

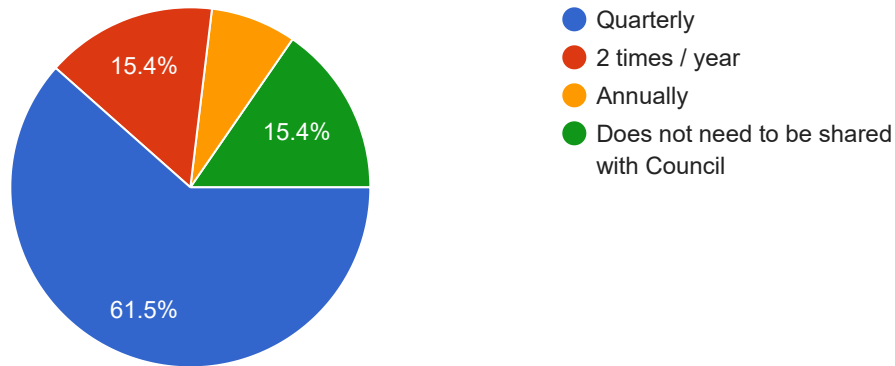


Possible New Administrator Update Topics



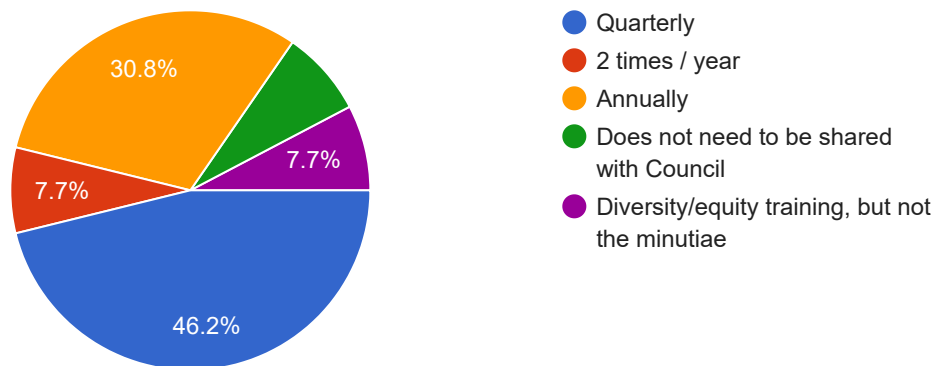

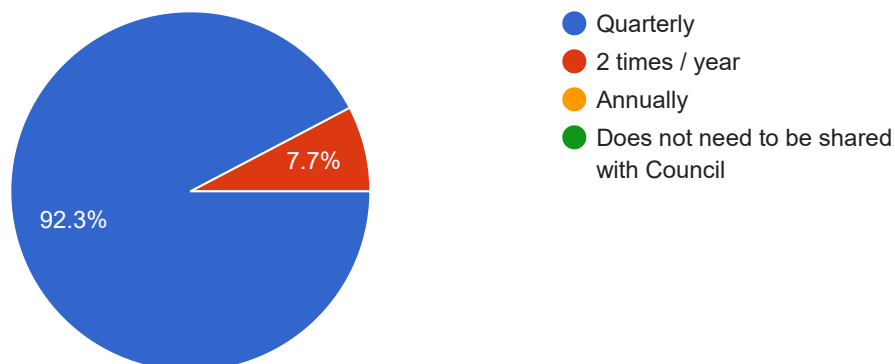

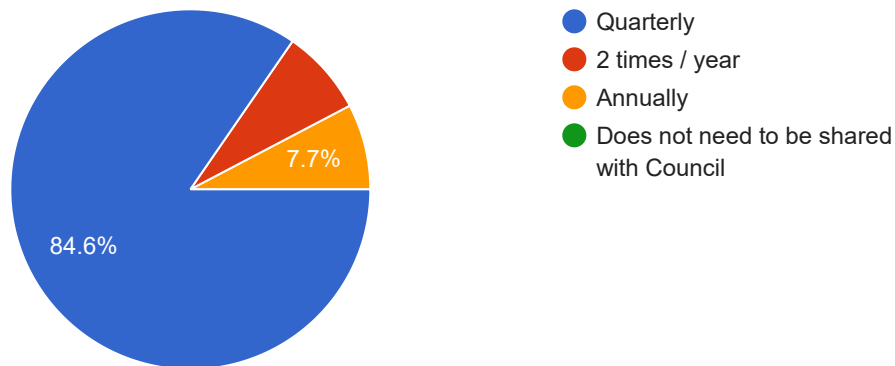
