Draft Meeting Minutes

- 1. Liz Pusch called the meeting to order at 10:01 a.m. in conformance with the Wisconsin open meeting laws.
- **2.** Attendees introduced themselves. Attendance was recorded in the table above. A quorum was present.

3. Review Roster

 A change was discussed at the last State Committee meeting. The BAS requested a nomination letter be submitted to document the changes for Dean and John.

4. Review and Approve Previous Meeting Minutes

- Liz to update the language details in the minutes.
- Kelly Tourdo made a motion to approve as amended. Motion seconded by Zach Newton. Motion passed

5. Specific Committee Items for Discussion (Public Comment)

a. Requirements for Completion: Review Class Attendance Requirement

Liz Pusch made recommendation that they remove the additional attendance requirements from the State Standards. Explained that attendance details may vary by committee and should be documented in the Local Standards and Policies. Upon committee request, Liz is to send the current exhibit A's with the meeting details. Liz Pusch reiterated the recommendation to include attendance details in their Local committee policies/procedures and/or their Local Standards rather than the State Standards.

Committee members expressed concern that sometimes they refer to the 90% attendance requirements in the State Standards with WTCS, apprentices and others. They appreciate the State Standards being the final answer so there is more than a local policy to enforce concerns. Liz Pusch will add this topic to the Joint BAS/WCTS Conference Agenda.

Darren Johnson made a motion to table this topic until the BAS and WTCS reviews further. Motion seconded by Zach Newton. Motion passed.

b. Standards: Section 2: Item 5: Discuss Adding DSPS Requirements

Liz recommends updating the State Standards to include the DSPS requirements. Sample language was provided. A motion was made by Kelly Tourdot and Seconded by Darren Johnson. It was not voted on.

A committee member made a suggestion to make it gender neutral and remove the gender reference. The language agreed upon was "All registered apprentices in Wisconsin are required to take and pass the State Journey Worker Electrical exam or Master Electrician exam prior to the completion of their Apprenticeship Contract".

The effective date will be 4/10/2024. Liz will send the guidance to BAS staff to make that change in Exhibit A's. The original motion did not apply after the discussion. A new motion was made.

Kelly Tourdot made a motion to update the current language in the Exhibit A and update the State Standards with the addition of both items. Motion seconded by Darren Johnson. Motion passed.

c. Standards-Feedback on Local Implementation

The BAS wanted to get feedback from the Committee. Jim Cook said they made the final edits and may roll out to all local committees that have approved. Liz asked to make sure to include the ATR's and Ben Stahlecker in those discussions. After much discussion, it was agreed that this is a very large and time consuming task. Liz will send an email to the committee asking for volunteers for work group participants. Kelly Tourdot volunteered to head that group up and can host the meetings.

d. Discussion on Program Term and Contract Cancellation for One year Passed Proposed Completion

The BAS wants to address the requirements of apprentices completing their apprenticeship contract timely. There are cancellations coming in for 7 and 8 year apprentices. The term is 4 years and the BAS grants one additional year to finish, There also is the option to extend the contract one additional year after the issue has been address by the Local Committee with the apprentice for extenuating circumstances. The other option is to cancel the contract and have them re-apply in the future.

The committee stated that the primary reason apprentices are taking longer is that they can't pass the journey worker exam. They also stated some concerns going back to the COVID time period. Additional dissatisfaction with the DSPS timeliness and organization. Director David Polk asked for the details of their concerns to be documented and sent to him. He is meeting with the DSPS on 4/11/2024 to address concerns.

The BAS does need the ATR's to initiate action for the apprentices that are in the program too long. The BAS often has no response from those apprentices. It is also important that the committees monitor on their own and address solutions and supports. Liz Pusch reminded committee members to document those discussions and actions.

6. Director's Call Discussion

- The calls are now approved to be recorded. You can find them on our website within the State Committee link.
- The BAS is partnering with Mentor Greater Milwaukee to help with mentoring apprentices. This is service is free to any committees that are interested.
- The BAS made a 20-minute harassment video. A cornerstone reminder will be sent to all State Committee members to watch the video and take the quiz. In the future Local Committee members will be asked to participate as well. It will be required to view one time.

7. WTCS Update

 Jamie Bernthal shared WTCS's goal to do a retrospect on the Tools of the Trade program. They are looking to assemble a focus group to analyze the program. Past recipients would receive a \$50 stipend to participate.

8. Other Discussion Items

- Jesse Jacques wanted to discuss the math requirements. The committee reviewed the
 options for meeting the entrance requirements. There was some concern that many of
 the technical colleges have different assessment tools or processes. Liz stated the BAS
 can work with them if they are having issues in their local area. Christina Jungwirth will
 reach out to Jess Jacques to discuss further.
- **9.** Electrical program participation was reviewed. No concerns or questions.
- 10. The next meeting will be October 9, 2024 at 10 a.m. Liz Pusch will send out a save the date.
- **11.** The committee adjourned at 11:23 a.m. following a motion made by Darren Johnson and seconded by Zach Newton.
