Medicaid and prohibition of funding for planned parenthood (provision of primary care in WI and inability to select provider). How work with OS to assure a strong public health system (HIV, family planning, primary care). Karen O will confirm who will be on from DHS team but assumes Arielle Exner and least one of the policy directors will be on.

- PHC alignment around budget cycle
- Once through reconciliation, more space to discuss budget proposal for FY26 (includes reorganization of CDC and HRSA, significant changes like block granting, reducing funding and consolidating public health prevention grants)

3. Medicaid Statement

- Communicating broadly with state legislators on Medicaid challenged by rapid shifting and changing. The letter relied on the analysis released by DHS which became old and outdated. There is concern was that the statement would cause confusion due to outdated information.
- Appropriate to send to targeted groups like Co-Chairs and staffers of JFC and leaders of legislature including minority and majority leaders in Assembly and Senate, but broad dissemination may not be strategic at this time.
- Potential to send a simplified statement as cuts to Medicaid are not good for WI and could be an opportunity to get PHC name recognition and support of DHS.
- Suggested revisions include: frame why cuts matters to public health including impact on health outcomes knowing access to care is a critical issue in WI and public health. Point to expertise in the topic and remove analysis elements.
- Best timing is likely now with shorter statement (to JFC today) and after analysis of actions in JFC today. Aisha, Lieske, and Jordan-Lindsay willing to work on revising the statement to send out today.
- A motion to accept revised version of statement for distribution to members of JFC and majority/minority leaders with incorporation of changes as discussed was provided by Jordan-Lindsay and seconded by Catoya Roberts. All EC members present voted in favor. No opposed or abstained.

			 Paula Morgen asked Lieske and the Issues Committee to take the feedback from the council regarding engagement with the budget cycle and review to identify opportunities during the budget cycle to solidify changes to our process in the future. Consider press releases as a tool for the PHC – lift up with PHC given last part of the PHC charge to inform the public. This could begin with informing health departments. If a press release to media, there would need to be a point person (not staff). The council has previously discussed the need for a public relations/communications committee.

for the committee and the work. The GovD that Aisha shared (see above) references, there are likely to be expected cuts coming from the CDC (likely 70% of what is usual). More limited funding means needing to cut back on preparedness work and hard decisions for prioritization are required. As such, there is a need to still maintain systems to fulfill our obligations to the state. With this in mind, the PHEPAC put together a letter identifying what would be recommended pending budget cuts to funding pertaining to preparedness (see above-"PHEPAC Funding Initiatives" and "Public Health Emergency Preparedness Prioritized Outcomes").

 What do you need from the PHC and the EC to help elevate this work? PHEPAC hasn't been able to share this letter yet. And, if there are other mechanisms by which this could be shared,

identifying those would be helpful.

- From the Issues Committee perspective, there is logic to have a
 document that could be shared that would also be sponsored
 by the PHC, given the charge.
- Is there a way to elevate the opportunity cost or what would fall off the plate if these outcomes are not achieved? Is there a minimum dollar amount that gets associated with these two priorities—how do the funders know how much this might cost? It's hard to know a specific number—preparedness covers a lot of different avenues including Cities Readiness Initiative (CRI) and labs. So, knowing just how much and how the impact based on dollar amount varies might be hard to quantify because there are a lot of interconnected pieces. For instance, 50% of the funding goes directly to LTHD agencies and 22% goes to labs (the rest goes to internal staff and administrative grant pieces)—cutting this will have broad ramifications.
- With timing of this funding source (July 1), getting something
 out now would be important. Later, the PHEP committee could
 explore both what would stop and how much funding could be
 looked at over time. Also, a simple addition related to national
 security language is important. At least a communication to the
 DHS Secretary as an audience would be necessary as well.

			 Who is the audience? Paula Tran (who can share with SO), OPEHC, WALHDAB, and LTHDs. Who is this coming from? The Council or both the Council and the PHEPAC jointly. EC is able to make decisions on behalf of the council and as such, can keep the rest of the PHC informed about the decision and the letter (via Paula Morgen). Thoughts on national security framing? Jordan sent some language to Brittany for consideration of added language in the opening paragraph. Motion to approve (pending national security language) provided by Jordan-Lindsay Morris Greer, and seconded by Catoya Roberts. Motion carries unanimously. SHIP Updates SHP committee is still being stood-up. Maggie has connected with Jamie Michael with WPHA/WALHDAB to recruit health officer representation. Maggie has also been connecting with other community groups for engagement and incorporation into the SHP committee. Maggie is expecting that membership will likely be identified and sorted by the next PHC meeting (August 1st). Maggie
