

Dear Secretary-Designee Palm and Members of the SDMAC Vaccine Distribution Subcommittee:

I respectfully urge you to include veterinarians, veterinary technicians, veterinary assistants, and other veterinary clinic staff in the Phase 1b prioritization list to receive the COVID-19 vaccine distribution.

Veterinary health care workers are essential frontline workers that provide critical care to both food/fiber animals and companion animals throughout the state and in Dane County in a clinical and house call capacity. Our clinic is currently providing medical, surgical, and urgent care curbside now with a huge demand for our services. If veterinary clinics and facilities were to close due to a COVID-19 outbreak among veterinary staff, there may not be accessible alternatives for patients. As a profession, we cannot work from home and currently, the provision of veterinary care via telehealth is not allowed under Wisconsin law. As a result, our patient care requires uninterrupted in-person/curbside visits and availability of our unique health care services.

I am disappointed to see veterinary professionals overlooked in this recommendation for the next phase of vaccine distribution. I respectfully urge you to include all Wisconsin and Dane County veterinary personnel in the COVID Phase 1b Vaccine Priority Group.

My name is Dr. Dawn Miksic and I am a veterinarian working in Oconomowoc, Wisconsin. I am writing to ask you to include veterinary health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

I am saddened to see that veterinarians are not considered health care professionals when it comes to vaccination for COVID-19. We do not treat humans, but our patients come attached to a human in the form of an owner with every interaction we have. We have worked hard to mitigate our staff exposure to COVID-19 with curbside service but my staff is potentially exposed on a daily basis as they still have close contact with owners when they are crawling into client cars to retrieve a pet or when talking to clients many of whom do not respect the mask mandate. We also bring owners into the

ntial worker status in March when the state was under quarantine.

We happily limited our use of PPE and conserved our surgical supplies to emergency or urgent need patients so more supplies would be available for our human health care professional counterparts. But that left us with less PPE and no N95 masks available for our protection.

this composite there is a shortage of veterinary care in our area and an overflowing number of new pets that were recently adopted. Owners are waiting hours in the emergency clinic parking lots where they used to wait minutes. They are waiting days for sick appointments when it used to be hours. And the veterinary specialists are scheduling out months before they can see a patient when often an urgent problem could be seen the same day. Our system is already taxed. I feel that we will catch up over time or we will hire additional staff and things will improve. But if any one of our staff gets COVID-19 it could shut our clinic down. We cannot social distance when we are treating animals. It requires one person holding the pet at a minimum while another examines the pet. We wear masks on a regular basis from the time we get to work to the time we leave. We remove them only to eat and drink. But as I have said we do not have N95 masks and we cannot social distance while doing our job, so if 1 staff rely it will spread to more of us. If we shut down our clinic for a rest of the veterinary clinics in the area and they are already overburdened.

In addition, there have been reports of veterinary patients getting sick and/or dying from Covid-19. Both dogs and cats and now ferrets and mink are at risk.

So please consider including Veterinary health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

My name is Dr. Bailee Stahl and I am from Madison, Wisconsin. I am an Emergency and Critical Care Veterinarian. I am writing to ask you to include veterinarian health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

I work at Madison Veterinary Specialist where we have multiple doctors and numerous staff including technicians, assistants, and support staff. We are a 24/7 facility and therefore have people here at all times. We have remained open to help as many animals as possible. However, while we try to keep distance from one another, that is impossible during patient care.

Our other services act as a curb side only practice, however on emergency we have more contact with owners. When possible, we are curbside but for euthanasia's and end of life visits, we are allowing owners to be present in small numbers.

It breaks by heart having to limit the amount of family that can be present to say goodbye to their beloved pet and it is difficult on myself and my staff to not be allowed to have clients visit when their pet is in the hospital for days at a time. While this is extremely difficult, we do it to protect our human health over the animals – which is tough as a veterinarian who has always put animal health first.

If we were able to be vaccinated, we would feel more protected as a clinic and be allowed to have clients in the building more often. This would allow owners to be able to say goodbye to their pets in their last minutes and it would allow owners to come visit and monitor progress of their pets that are severely ill and in hospital for a long time. I truly believe this would help the animals get better quicker and it would help the owners emotional health as they hate being away from their animal.

I am responding to the document entitled "Wisconsin State Disaster Medical Advisory Committee Vaccine Distribution Subcommittee Recommendations for the Wisconsin Department of Health Services for COVID-19 Vaccine Priority Group 1b".

First of all, thank you all for taking on the unenviable task of organizing vaccine distribution and priority. It is likely one of the most important tasks of the decade.

I believe that veterinarians and veterinary staff should be in group 1b for COVID vaccine priority for the following reasons:

- 1) <u>Coronaviruses including SARS-CoV-2</u> (virus causing COVID-19) are ZOONOTIC. This means they can spread between animals and people. Veterinarians and veterinary staff are at the forefront in treating all species of animals from fish to ferrets (close relative of mink) to bats to cats to cows. We have close contact with these animals, which may include exchange of the SARS-CoV-2 virus if the human is infected. ANY passing of virus from human to animal (or animal to human) gives the virus the chance to mutate or spread (as evidenced on mink farms). Vaccinating veterinarians and staff will hopefully decrease this risk.
- 2) The veterinary profession has been able to respond quickly to the pandemic and we are often able to adopt "curbside" protocol to reduce traffic flow in the hospital. Even with curbside, our staff has to go to the car to retrieve the animal. Often, the owner is not wearing a mask and is up close to our staff to explain why they have arrived at our ER. There are also situations where owners have to come into the building such as for humane euthanasia. In these situations, we wear a face shield on top of a face mask but cannot avoid close contact with the grieving family and pet. Understandably, the crying family members are frequently pulling down masks to blow their nose, etc. Vaccination would help to protect veterinarians in these types of unavoidable situations.
- 3) We cannot socially distance from co-workers in many situations. Generally, one person restrains or distracts the animal while the veterinarian does the wound repair, examination, blood draw, etc. During these times, we have no choice but to be within 1-2 feet of each other's (masked) faces. Obviously, we try to limit these situations but most are unavoidable. Vaccination would help prevent spread in the clinic and therefore in the general population as well.

- 4) <u>Veterinarians ensure the health and adequate supply of agricultural animals.</u> There is already a serious shortage of food animal veterinarians. Sick veterinarians missing work or dying due to COVID-19 is a serious threat to our food supply. Enough said.
- 5) Veterinarians could assist human health care providers if the human health care industry becomes overwhelmed by COVID-19 cases. This is especially a possibility given the recent spread of the new SARS-CoV-2 variant. Obviously, veterinarians are not directly trained to take care of humans but humans are mammals just like cats and dogs. In the situation where there are not enough doctors, nurses, CNAs, EMTs, etc to care for ill people, veterinarians could step in to help out and assist healthcare professionals.

In summary, I strongly believe that veterinarians and veterinary staff should be in group 1b for vaccine priority. Regardless of the ultimate decision, thank you all for taking the time to read my letter and consider my opinion.


My name is Sarah Stock and I am from Madison, Wisconsin. I am 3rd year veterinary student at the University of Wisconsin School of Veterinary Medicine. I am writing to ask you to include veterinarian health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

Veterinarians are bitten, scratched and defectated on every day, at best. We're also overwhelmed with compassion fatigue, low income to debt ratios and frustrated clients. Our difficult job is being made harder by this pandemic as veterinarians must put their health on the line to keep their doors open. While veterinarians don't work on human patients, staff spend much of the day in close contact with each other to complete procedures and provide restraint/monitoring, preventing social distancing. Even with many veterinary clinics switching to parking lot dropoffs, there is a certain level of physical contact with the public that takes places and in some cases, such as in-home euthanasias, there is also limited ability to distance. Pet owners and meat, poultry and dairy producers cannot afford veterinary clinics to close due to COVID outbreaks. A closed clinic can mean the difference between life and death or suffering and treatment. Therefore it is imperative that veterinarians are vaccinated as soon as possible.

Furthermore, as part of our curriculum, 1st-3rd year veterinary students have hands-on learning opportunities requiring us to interact with each other in close quarters on campus. These activities range from anatomical dissections to ovariohysterectomy surgeries on live patients and CPR code practice-runs and are absolutely essential to the development of our medical abilities and understandings. Each time I attend a lab, I recognize that I am putting my health and the health of those in my household at risk. I'm also extremely aware that just one COVID-positive student showing up to class after a false-negative test could infect 20+ students (though we wear PPE, many procedures require proximity) and put a temporary hold on our learning.

In a few months, I will enter my 4th year and begin clinical rotations, where I will be in close contact with lab technicians and other doctors all day as we huddle around the patients we're trying to care for. I will also be traveling to externships as well as routinely meeting the general public at their cars to retrieve/deliver their pets and talk with them about medical histories and exam findings. Though I will may have the same exposure level as an ICU nurse, I will still be spending my day in close contact with pets, owners, and colleagues that could be COVID positive. My school is doing everything in their power to minimize risk and provide PPE, but quite frankly, social distancing can't always be maintained when a life is on the line (especially when our job requires us to crowd around a kitten for restraint and vaccines).

We're running out of time to make up clinical experiences. If I miss a lab now because I get sick, it's extremely hard to find time to make up that experience. Once I hit 4th year, our schedules are set in advance and if I'm sick for two weeks, there's nothing I can do to get those hours of experience back. I already feel like our education has been greatly compromised by this pandemic and it is crucial that everything in the state's power be done to preserve learning at the school of veterinary medicine to ensure that the next four years of DVM graduates are adequately prepared to care for the animals of Wisconsin.

I am writing to ask you to include veterinary health care professionals, as well as other veterinary staff, in Phase 1b of the Wisconsin COVID-19 vaccination plan.

As a 5 doctor, small animal veterinary practice, we are a very busy practice, and we have become only busier since the beginning of the pandemic. We have remained open, via curbside service to our clients, going out to them in the rain, heat, snow, cold, and everything in between, and bringing our patients into our practice to do what services they need. This has put a huge challenge on our staff, our clients, and has limited our ability to fully serve all of our clients and patients fully. We have had to turn away more appointments than we would like to talk about because we just don't have the time because of the way we have to do business now. In October, the worst almost happened, as over 25% of our staff contracted COVID, and more needed to stay home because of exposure and childcare concerns because of exposure. My name is Elana Frankenthal and I am from Middleton, Wisconsin. I am a veterinarian. I am writing to ask you to include veterinary health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

I work at Sondel Family Veterinary Clinic in Madison, WI where we work to keep dogs and cats healthy. Although we have been able to practice curbside medicine and have minimal interaction with the public, we are forced to work very closely with our staff without the ability to safely socially distance and have been working exceptionally long hours since COVID-19 began. Our exam rooms do not allow for 6 feet of distance and practicing medicine on animals MUST be done with close contact with one another. Restraint, monitoring anesthesia, performing surgery, all require very close contact with one another. We all wear masks but our close contact with each other to simply do our jobs results in our entire practice needing to be shut down if one of our staff breaks with COVID-19. This would be extremely detrimental from a health standpoint to animals in our community. Our patients would need to seek veterinary care elsewhere, but other clinics in our area are practicing at capacity and booking out WEEKS to MONTHS in some cases. Our veterinary emergency hospitals are understaffed and the wait times are sometimes as long as 4-8 hours to be seen since they're working at capacity as well. Curbside medicine takes much longer and prevents veterinarians from seeing the same number of patients we typically see pushing our schedules out. My name is Mary Frances Picone and I live in Wauwatosa, Wisconsin. I am a pharmacist who works at Froedtert & the Medical College of Wisconsin and was included in the phase 1a vaccination group. It is a Veterinary Oncology Intern at University of Wisconsin School of Veterinary Medicine. I am writing to ask you to include veterinarian health care professionals, veterinarians and veterinary technicians, in Phase 1b of the Wisconsin COVID-19 vaccination plan.

Veterinary health care workers cannot work remotely or work from home. Currently, the provision of veterinary care via telehealth is not allowed under Wisconsin law. As a result, the provision of patient care requires uninterrupted in-person provision and availability of health care services. One method of reducing risk for staff that clinics in my area have implemented is to reduce their clinic staffing volume and keep certain groups rotating in the clinic together (eg, the same vet and technicians). Since our veterinarians have to put themselves at risk every day, it makes sense that as a clinic they should try to implement all measures possible to reduce staff risk. However, this particular approach has meant that it is very challenging to see a veterinarian on short notice for those urgent but not emergent issues that might come up, as well as make any typical preventative care appointment.

I myself own 2 dogs and have had to take them to my veterinarian several times throughout the pandemic, both for routine and urgent care. My veterinarian here in Wauwatosa has implemented a curbside practice, where owners wait in the car for the duration of the visit, but I interact with the technician several times in the course of a visit. Additionally, due to the reduced staffing, it has been incredibly challenging to make an impromptu appointment for those issues that come up and require a visit; once clinics opened back up, they were playing quite a bit of catch-up to manage their current clients and issues that had cropped up during the several months we were completely shut down. For example, in September, one of my dogs experienced an urgent issue where I tried to seek care from my typical veterinarian, but was unable to schedule a same-day appointment and had to go to a new veterinarian who did not know my dog or have any of her records. In the next month, another urgent

v dog started experiencing very severe diarrhea. Again, I had an appointment within a reasonable time frame for my dog re a prescription for modications that would treat the diarrhea. I seek care at and the continued for several more days with no treatment, it might have become an emergent issue.

Our veterinarians and veterinary technicians are vital to caring for pets, as well as other animals (eg, livestock), throughout the State of Wisconsin. They put themselves at risk every day to provide this care, and I think they warrant inclusion in the phase 1b group, alongside of the pers, prisoners and others who live in congregate living settings. I hope you will reconsider their location, as currently they seem to be falling into the very last vaccination group (ie, general public). I know I consider my pets to be part of my family, almost like children, so I consider my veterinarian a health care provider and essential worker. If they were able to receive the vaccine, they could benefit from the great protection it offers and possibly make modifications to current practices that might improve their abilities to provide care at the volume it is needed right now.



My name is Dr. Amber Mayne and I am from Sun Prairie Wisconsin. I am a Veterinarian. I am writing to ask you to include veterinarian health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

I am one of 4 veterinarians at Token Creek Veterinary Clinic in Sun Prairie, WI. We provide essential veterinary care to over 3600 clients and over 7000 pets. We provide everything from preventative health care, continuing medical to urgent and emergency care for our patients. We are also critical in educating our pet owners regarding pet and public health issues and concerns. Veterinarians are essential health care providers not only to pets but also to food animals and in providing public health services regarding our food supply. A COVID 19 outbreak in our clinic would result in the loss of Healthcare for pets, providing essential medications and continuing management of ill patients, and providing education and peace of mind to our clients whose pets are like family members. A COVID19 outbreak would mean a loss of wages for our personell, all of whom have families to provide for. It would mean loss of care for over 7000 pets. For veterinarians involved in the care of food animals and public health, it would mean the loss of that first line of defense we provide, making sure our food animals are healthily raised, processing plants are upholding cleanliness and proper protocols for processing food, being aware of and reporting potential devastating infectious and zoonotic disease outbreaks.
