There will be a review of the NBS conditions that are on the Birth Defects Registry list.• Carnitine palmitoyltransferase IA (CPT IA) deficiency was nominated to be added to the NBS panel of conditions. It is a fatty acid oxidation disorder associated with hypoketotic hypoglycemia and liver failure. The Secretary's Advisory Committee on NBS recommended to add the condition and is preparing a report of their recommendation for the Secretary of DHS. |

Marijke has asked to review the webinar and to request a work around to access the content.</p> <p>Prenatal education pilot – Grant funding was no longer available, so this project was put on hold.</p> <p>Outreach to Amish birth attendants –Quarterly Educational Sessions have included extensive NBS updates and instruction in addition to materials related to risk screening and obstetrical emergencies.</p> <p>NBS training session for all 3 screens in the works for licensed midwives – spring 2018 (will offer CEUs for providers)</p> <p>CCHD – updates to WI SHINE website including how to reach Marijke and how to access the on-call pediatric cardiologist.
