IV. Public Comment on Issues Affecting Assistive Technology Users or on the State Plan on Assistive Technology, 2018-2020 (dhs.wisconsin.gov/publications/p02162.pdf)

- Cindi Pichler with IndependenceFirst requested an update on device reuse as outlined in the State Plan on Assistive Technology, 2018-2020.
 - Laura Plummer responded that device reuse services continue to be provided by the Department of Corrections (DOC) for refurbishment for durable medical equipment (DME). DOC is establishing relationships with entities to purchase used DME devices from them. Device reuse also continues to be tracked by the Independent Living Centers.

V. Assistive Technology Program Updates

- Jenesis Lindbo shared the following update from ATAC member, Shar Brunes, whom was unable to attend this meeting. "Please let them (ATAC) know that we are applying for the new Alternative Finance Program Request for Proposals? We would be interested in their ideas/opinions as to what would be beneficial to our consumers."
- Billy Maudlin from the Public Service Commission of Wisconsin (PSCW) shared that there has been a drop in Telecommunications Equipment Purchase Program (TEPP) applications. Typically PSCW receives 75-100 TEPP applications per month and in April 2020 PSCW has received 59 TEPP applications. This has also translated into lower expenditures for the TEPP voucher program. Billy Maudlin shared that the Telecommunication Relay Services (TRS) program has seen a longer wait time for captioned phone responses and longer call times overall. The revised TEPP equipment list has been finalized, but will not be made public until some additional policy protocols are approved by the Commission.
- Lisa Woods shared that the ATAC member orientation meeting was helpful
 and that she liked having all of the materials available online in one place.
 Lisa Woods stated her agency has converted to providing services entirely on
 a virtual basis.

- Mike Hipple reported that the Wisconsin Augmentative Alternative
 Communication (AAC) Network hosted their regional meeting virtually in April
 2020. The topic for this meeting was quality indicators for assistive technology
 used in schools. The next Wisconsin AAC Network meeting will be in August
 2020 and will be on wheelchair positions. Mike Hipple is looking for speakers
 on wheelchair positions.
 - Laura Plummer is happy to correspond with Mike Hipple on this.
- Cindi Pichler shared that she and another staff member from IndependenceFirst have done three virtual presentations to college prep programs on assistive technology.
- Jason Ostrowski shared updates about the Samsung product testing he has been doing.
- Jim Denham from the Wisconsin Council of the Blind and Visually Impaired shared information about an online course recently held regarding apps for people with vision loss. There will be additional trainings coming up. Jim Denham also shared that the Library for the Blind has had to re-visit how they are providing services and this has involved helping people access electronic reading materials through library apps.
- Andrea Bertone from the Wisconsin Department of Public (DPI) Instruction shared that the next online assistive technology resource that they will be doing is on augmentative and alternative communication (AAC) devices.
 Jennifer Schubring will be the trainer. These trainings will be captioned and added to the DPI website. Andrea Bertone mentioned the CARES Act funding and that she may have some input into assistive technology applications which can be paid for with this funding source.
- Abbigail Marx shared that Waisman Center Communication Aids & Systems
 Clinic (CASC) has been providing services virtually and one of the challenges
 experienced has been how to do communication assessments remotely.
- Andrew Bordeaux shared that COVID-19 has highlighted that access to assistive technology is impacted by many factors and that not everyone has access to devices and connectivity. This led to discussion about the barriers

an individual or families may have in accessing the internet. This access may be impacted by financial means, geographical availability, ability to obtain technology, and the skills to use it.

 RaeAnn Fahey from the Wisconsin Department of Health Services (DHS) shared DHS has promoted free and low cost internet options that had been shared by PSCW. These were shared via the Frequently Asked Questions (FAQ) documents provided to IRIS and Family Care programs.

- Laura Plummer led the discussion regarding the ATAC having three vacancies. A review of the current ATAC membership base was provided and members reviewed the applications and submitted to serve on ATAC.

VII. Wistech Program Updates (Consumer Stories, Quarterly Reporting, Trainings, and COVID-19 Impact on Delivery of Assistive Technology Services)

- Laura Plummer led the discussion on Wistech program updates including a review of issues and actions surrounding the COVID-19 pandemic.
- The pandemic impact on device loans, demonstrations, and reuse was
 discussed via email correspondence with program subcontractors.
 Information was shared with these programs in late March 2020 that there
 would be fiscal support for the purchase of Personal Protection Equipment
 (gloves, masks, cleaners) and related assistive technology equipment such
 as UV sanitization wands.

- Guidance on providing virtual services under the Assistive Technology (AT)
 Act was also shared with WisTech subcontractors in March 2020.
 Administration for Community Living (ACL) issued guidance on acceptable video meeting.
- WisTech staff reached out to obtain information and guidance on methods to reduce social isolation through the use of technology. Unofficial documentation was provided and directed towards both facilities and families.
- CARES Act funding provided support to Aging and No Wrong Door programs.
 In ACL's guidance Aging and No Wrong Door programs to collaborate with AT Act programs were. WisTech staff has worked with the Office for Resource Development (ORCD) so when Aging and Disabilities Resource Centers receive these funds they are aware of the WisTech program's ability to provide information and support on assistive technology.
- There are numerous webinars on the topics of providing remote or virtual services, ensuring accessibility for video meetings, and product demonstrations. On a national level, Independent Living Centers, AT Act Programs, and Vocation Rehabilitation programs have shared their strategies to ensure continuity of services .These resources are routinely shared with WisTech subcontractors.
- Laura Plummer shared WisTech program data from quarter 2 (January-March). Program data, including the narratives will be sent out once compiled. WisTech is also collecting data on instances when services are not able to be provided as a result of the pandemic. This information is being collected through a survey form.
- Laura Plummer is participating in an in-depth training on Information Communication Technology (ICT) website accessibility. This training is being done virtually and is hosted by the AT3 Center.
- Lisa Sobczyk and Laura Plummer provided a second training to the Wisconsin Technical College System on ICT and accessible PowerPoints.
- Inclusa requested a presentation on assistive technology resources in Wisconsin, which will take place in May 2020.
