### Bureau of Prevention Treatment and Recovery updates

S. Martindale

S. Martindale shared that:

Wisconsin Act 249 was signed. This act will lead to the creation of crisis urgent care and observation facilities which will provide staff and services to de-escalate and treat young people and adults experiencing a mental health crisis without long wait times or families having to travel for hours.

Wisconsin Act 219 was signed. This act directs DHS to establish a pilot program to provide virtual behavioral health crisis care services for county or municipal law enforcement agency officers to utilize while on duty.
