# 5. Specific Items for Discussion (Public Comment)

# a. Wage Repayment Agreements

i. Liz Pusch provided an overview of recent concerns with sponsors and employers requiring apprentices to sign wage repayment agreements that could affect them in the instance of leaving employment with their assigned employer either within the course of their apprenticeship or after completion. Liz shared a memo that was issued in Feb 2024 outlining the statutory requirement of paid related instruction and the prohibition of requiring the repayment of contract-required PRI. The Advisory Council discussed this item at the February 2025 meeting and subsequently approved language for addition to the WI Apprenticeship Manual to clarify this. Notification will be provided when the Manual update is completed. Sponsors or employers can reach out to BAS for assistance in complying with this requirement, if needed.

#### b. Discussion on Status of Carpenter-Heavy Highway Pile Driver Program

i. The committee wants to start a new statewide JAC specifically for the Carpenter-Heavy High Pile Driver apprenticeship program. This new JAC will cover the entire state except for the 6 counties currently covered by the SE WI Area Carpentry JAC. They currently cover Kenosha, Milwaukee, Ozaukee, Racine, Washington and Waukesha. Committee members stated that the curriculum and work processes for this specific program greatly varies from the other programs, so it makes sense for it to have its own JAC. The committee also believes by having a separate committee, they will be able to grow the program and represent their apprentices and contractors more efficiently. This new committee will continue to conduct their related instruction courses at the Madison

training center.

- ii. Liz Pusch reminded the committee they will now need standards, committee members and selection procedures submitted to BAS. The current committees will also need to transfer their current Pile Driver apprentices

## c. Discussion on Two-Term Variable of State Exhibit A

- i. The committee discussed possibly removing or editing the two-term variable in the exhibit a of their contracts so apprentices could complete their contract prior to 4 years if they met all of their related instruction and on the job training hours. The current term of apprenticeship listed in the Exhibit A of the carpenter program states, "The term of apprenticeship shall be Time-based, which has been established to be 4 years of not less than 6,240 hours". This means even if apprentices complete all of their paid related instruction and on the job training hours early, they still have to meet the 4-year requirement to complete their contract. It also means that any early completions would technically be in violation of the apprenticeship contract.
- ii. The committee discussed possibly removing the 4-year requirement and only having an hour requirement. However, BAS reminded the committee this could potentially cause other issues, such as apprentices going over the maximum amount of time allowed in the apprenticeship. If the apprentices did not work 2080 hours a year, it would cause them to go over the time frame required to complete (1 year past their estimated completion date). This change could potentially cause more apprentices to be cancelled for going over their term date.
- iii. The committee decided on potentially adding language in the state standards regarding early completion or in the special provisions section in the Exhibit A. Liz Pusch recommended adding proposed language: "Apprentices can complete prior to the 4-year term if they complete the following items...". The language regarding early completion would have to be listed in the Carpentry State Standards and would outline what local committees need to add to their local standards if they want to allow for early completion. Lastly, the request for early completion has to come by request from the apprentice.
