3. 2023 Data Dictionary (informational)

Retired data elements: Angina Pectoris and mental/personality disorders

New data elements: Pre-existing conditions- the retired element of mental/personality disorders has been separated into 6 elements: bipolar I/II disorder, major depressive disorder, other mental/personality disorders, post-traumatic stress disorder, schizoaffective disorder, and schizophrenia.

New data elements: There is one entirely new required data element of primary trauma service type, which asks the primary service type responsible for the case of the patient, either adult or pediatric

which asks the primary service type responsible for the case of the patient, either adult or pediatric. Optional Wisconsin changes: Supplemental cause of injury, first antibiotic administration time and date, notes sections.

4. EMS Data Outcomes (informational)

Elite and Patient Registry- prehospital data from the EMS look up. When this is used, you can opt to send back the data to the provider who started the ePCR. They can see totally ICU days, ventilator days, hospital admission date/time, ED disposition, hospital disposition, ED first systolic BP, ICD-10 cause of injury, ICD-10 procedures, ICD-10 diagnosis, hospital discharge summary.

Trauma care facility initiates sending data back to EMS.

- Option 1: manual for individual records
 - Facilities>incidents>incident>toolbar>form options>send outcome data
- Option2: Send all record upon incident marked as complete
 - Set up> facility settings and resources>workflow>mark as complete
