- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Dave Aldag in conformance with the Wisconsin open meeting laws.
- 2. Mr. Smith recorded attendance. A quorum was present.
- 3. The committee reviewed the current roster. The committee reported that Mr. Scott Bartz should be added to the Employee side.

#### 4. Actions

#### a. Approve the minutes.

The state committee approved the minutes as revised.

#### b. Review related instruction as part of the five-year cyclical review.

Ms. Nakkoul and Ms. Terri Johnson reviewed the objectives of the cyclical five-year review of related instruction: ensure the curriculum is current for industry needs, aligned with available youth apprentices, and aligned with other post-secondary education paths.

**Action:** WIDS will create a survey of related instruction, and BAS will distribute it to the state committee. The state committee's responses will be shared with the instructors; the instructors' recommendations will be shared with the state committee at its fall meeting.

#### c. Review state standards and applicant assessment scores.

Mr. Smith reported that the Bureau will review the statewide minimum applicant procedures for construction apprenticeships this summer because the initiative is now in its fifth year and Mr. Polk is now Director. He asked attendees how well their minimum scores work.

The state committee reported that the scores work well; joint apprenticeship committees follow the scores recommended by the Bureau.

#### 5. Discussions

#### a. BAS Director's Call with State Committees

Director Polk reviewed that the Bureau implemented the call to discuss items appropriate for most or all state committees in a single, efficient forum. He asked attendees for feedback on the call, which the Bureau will report to the WI Apprenticeship Advisory Council.

Attendees reported the following: the new format is helpful and efficient; write the invitation more clearly to distinguish it from similar events; and include more opportunity for questions and answers.

#### b. Modified format of state committee meetings

Director Polk reviewed that discussing apprenticeship-wide topics on the Director's Call will streamline state committees' agendas to their specific policies and content. The agendas will allow for follow-up questions to the Call and "other" topics. The meetings will likely be shorter. Mr. Smith noted that, at the request of the state committee, meetings will use a hybrid format.

#### Attendees agreed and appreciated the modifications.

#### c. Pending review of Wisconsin Apprenticeship Manual

Director Polk reported that the *Manual* was reviewed and approved by the Council's Policy and Standards Subcommittee. It will be reviewed by the full Council in June. Once the Council approves the revisions, it will become an official working draft and a 90-day public comment period will begin. After the 90-day public comment period, all input will go back to the subcommittee and the Council for final approval.

Director Polk added that the Bureau will make the original version, revised version, and a summary of changes available electronically.

The state committee asked whether the Technical Assistance Guide trainings will resume. They are required for new members to local apprenticeship advisory committees. Director Polk confirmed that the trainings will continue; the Bureau is scheduling them now. The Bureau will email the final schedule to the state committee.

#### d. Subsequent review of state committee standards

Mr. Smith explained that the *Manual* provides the boilerplate language that constitutes 90% of each state committee's standards. Therefore, once the *Manual* is approved, BAS will update all state standards accordingly. He emphasized that the state committee's unique policies—such as its Exhibit A—will not change. Rather, those are always available for the committee to review at its discretion.

Attendees did not have questions or comments.

#### e. Other

Attendees did not have questions or comments.

- 6. The state committee reviewed the participant statistics and did not find discrepancies.
- 7. The meeting adjourned at 10:45 a.m. The Bureau will schedule the next meeting via electronic survey.
