The council is focused on the Mental Health Block Grant from the lens of access and equity and how the constraints of the state mental health system impacts access.

3: Mental Health Block Grant Report Summary

Mental Health Block Grant Planner Madeline Johnson presented an overview of the block grant and timeline of the application which is due September 1, 2021.

4: School Safety Presentation

Lieutenant Nathan Cihlar, Officer Cornell - SRO, and Officer Frank Wierzbanowski- SRO from from the Wausau Police Department, Andy Grimm a school counselor and district administrator for the Wausau School District, Kimberly Moore, MSW and Chuck Kerstell from the Northcentral Healthcare Center presented about how the school district and crisis services partner with the Wausau Police Department. They highlighted characteristics of their SRO/School partnership such as a focus on building community and relationships, family and student wellness, a student-centered whole-child approach, a restorative approach, and collaboration between crisis and SRO's in schools. The SRO training includes a diverse range of topics related to school safety, working with underrepresented youth, trauma-informed practices, crisis response training with school personnel, etc. The district has an MOU with the law enforcement agency which includes clear definitions of roles and responsibilities. The SRO is seen as an equal part of the educational team. The positions are funded half by the city and half by the school district.
