

Public Notice of an Air Pollution Permit Application Review

Facility Description.

Wisconsin White Sand, LLC, located at 12491 Franklin Road, Byron, Monroe County, Wisconsin, FID 642028420, submitted to the Department of Natural Resources (DNR) a permit application, including plans and specifications for the operation of an industrial sand processing facility.

Air pollution control operation permit no. 642028420-F01.

Application Review.

DNR has made a preliminary determination that the application meets state and federal air pollution control requirements and that the permit should be approved.
