 - a) Medicaid Reimbursement for Community Health Workers
 - i) Patty: Met with the Milwaukee Area Health Education Centers staff. Team was briefed on the status of legislation. Identified reimbursement as a barrier. Will attend virtual conference next week to ensure draft is in alignment with need.
 - b) Improving Maternal and Infant Health Outcomes (larger umbrella)
 - i) Ellen: Met with Humana and United Health Care staff. Requested meeting with DHS Medicaid staff. Aware of current legislation on maternal and infant health outcomes.
 - c) Smiles for Life Dental Access for all of Wisconsin's Children
 - i) Elizabeth: Met with Dr. Dunkel and Hannah at DHS to learn about oral health history in Wisconsin and ideas tried in the past. The meeting helped narrow scope of draft.
