 - a. Ruth: Discernment between question and known. Enough to do job effectively and no more. Trace can be more difficult than other areas as per the wide amount of cases trace receives
 - b. Kathy's position is that buffer (in some units)
 - c. Evidence transmittal forms have been updated
 - d. Working on a new laboratory management system to filter information down to analyst seeing absolute essentials (ex: different visibility for supervisor and analyst)
 - i. New LIMS in process (implementation ~2 years out)

 - b. How to address misdemeanor cases
 - i. Amber Hahn –Unidentified substances submission could be clearer, Speedy trial demand could be included on transmittal

 - NR –3rd person to step in and label is unfortunately not always possible due to staffing shortages
