Dear Secretary-Designee Palm and Members of the Vaccine Distribution Subcommittee:

Our undersigned organizations represent much of Wisconsin's food and agriculture industry. Collectively, we represent thousands of Wisconsin farmers, farm workers, farm service and supply workers and food processing workers. We greatly appreciate your leadership in helping navigate the state through the greatest public health crisis of the past century, but the next stage of addressing the crisis is distribution of the vaccine. We were very troubled by the recommendation made by the State Disaster Medical Advisory Committee (SDMAC) Vaccine Distribution Subcommittee to exclude food and agriculture workers from Phase 1b of the COVID-19 vaccine allocation.

Since the SDMAC recommendations were issued on Tuesday, the federal government announced a dramatic change in the disbursement of significant amounts of the vaccine which had been held in reserve. The limited number of doses the state was previously slated to receive certainly influenced the recommendations of the SDMAC.

Given the anticipated release of the additional vaccines, the addition of more essential workers such as those in food and ag to the 1b distribution should now be viable.

Food production and agricultural workers are critical to providing and maintaining the food supply that Wisconsin, the nation, and so many countries beyond rely on. Administering the vaccine is essential to this workforce is essential for these industries to continue feeding American families.

Our industry has worked hard to protect our workers and ensure that they are safe while keeping Wisconsin's food supply chain operational and uninterrupted throughout the pandemic. Farm and food production workers have a documented increased risk of acquiring infection because of their increased exposure to SARS-CoV2 (COVID-19).

Our workforce has an increased risk of transmitting disease to others because they work in close proximity to each other and, in some agricultural settings, they live together in communal housing and travel to work using shared transportation. The demographics of this workforce also highlights that a significant percentage of the population has a limited ability to miss work and a greater risk of financial hardship if they do miss work.<sup>[1]</sup>

# Accordingly, we ask that the Department include food and agriculture workers in Wisconsin's Phase 1b designation.



#### Good morning,

Wisconsin's Safer At Home order went into effect on March 25, 2020. The goal of the order was to prohibit nonessential travel and limit gatherings to help flatten the curve of COVID-19 and ensure capacity of Wisconsin's health care system.

There were three industries noted in that order as being reasons to leave your home: Healthcare, Pharmacy and **Grocery (Food and Supplies).** 

As the leader of an Organization that employs over 530 employees that **provides over 130,000 cases of food and supplies**, including dry goods, cleaning products, paper products, meat, dairy, produce and frozen food to independent grocery stores around our state of Wisconsin **EVERY DAY**, I was so disheartened to share the news that our industry was moved down the list for potential COVID-19 vaccine with my employees.

I understand this committee is made up of many front-line heroes that were beyond critical and essential over the past 10 months, and you are more than deserving of the vaccine, I 100% support that direction. I agree with everyone that was in the Group 1A, they all need it more than the rest of us.

However, your recommendations of persons to be included in Group 1B I do not believe make sense. On October 29, 2020, the CDC published the "COVID-19 Vaccination Program Interim Playbook for Jurisdiction Operations". Their definition of Phase 1B was as follows: "People who play a key role in keeping essential functions of society running and cannot socially distance in the workplace (e.g....food packaging and distribution workers..."

I commend the subcommittee on a well thought out and equitable 1B plan that is also operationally feasible.

My public comment is under the definition of public-facing essential workers, I'd ask you to consider food supply (especially grocery store workers) as well as public transportation operators (at least buses). I think to March and April last year when locally we saluted our grocery store employees and bus drivers as "heroes" for keeping society functioning as critical infrastructure in uncertain times and personally believe they meet the 1B criteria:

- Benefits- being around so many people every day, they have the potential to be superspreaders and they disproportionality live in the communities of color that have been the hardest hit locally here in Milwaukee County
- Population size- relatively modest... I'd guess somewhere around 150K statewide but not my area of expertise.
- Vulnerability- exposure to lots of people, but social distancing and masks have protected them well. Many live in vulnerable parts of MKE County from local experience.
- Additional considerations:
  - Advances racial and health equity goals, as these workers are disproportionately from the vulnerable communities and communities of color in Milwaukee County.
