Selection Criteria: (1) Cause of Injury (COI) code = 83 Covid-19 and Nature of Injury (NOI) code = 83 Pandemic; (2) COI = 83 and NOI <> 83; (3) NOI = 83 and COI <> 83; (4) Injury Description contains the word "Covid" or "Corona"; neither COI = 83 nor NOI = 83 (and therefore by De Morgan's laws claims for which COI = 83 and NOI = 83 are automatically excluded from this subset); claims with an injury description that contains the word "Covid" or "Corona" but which are clearly not Covid claims have been manually excluded. E.g. "Working from home due to Covid, back strain due to poor ergonomics", "Two week shutdown due to Covid, warehouse reopen and back strain due to heavy lifting", "Back strain due to loading the Corona Machine".
