Our hospital provides emergency, specialty referral, and primary care veterinary services for pets and their owners across the state of Wisconsin and from other parts of the Midwest. The work that myself and other veterinary health care workers do simply cannot be performed remotely (and is forbidden under Wisconsin law). Closure of our veterinary hospital would pose serious, and in some cases, fatal, consequences for the patients that we serve.

Veterinary health care workers also play a crucial role in protecting public and animal health via our involvement in food safety and surveillance of zoonotic diseases. A hospital closure would be of great detriment to our students' education – the food safety and inspection veterinarians and epidemiologists of tomorrow. These are consequences that we will not even realize for years to come.

My name is Rachel McMahon and I am from Madison, Wisconsin. I am a veterinarian at the University of Wisconsin School of Veterinary Medicine. I am writing to ask you to include veterinarian health care professionals in Phase 1b of the Wisconsin COVID-19 vaccination plan.

As an Oncology Clinical Trials Intern at UW Veterinary care, I am responsible for enrolling companion animals with naturally occurring cancer into clinical trials and overseeing their treatment and care. Many of these clinical trials have the potential to inform future clinical trials for human cancer patients. Unfortunately, severa

d only recently have some trials begun enrolling again. Our service also provides life-saving and/or quality-of-life improving standard of care therapy to pets with cancer from all over the state. If the Oncology Service at UW Veterinary care was forced to close due to a COVID outbreak, many pets would face delays in treatment (clinical trial therapies and standard therapies that cannot be performed elsewhere) that may lead to more rapid progression of their cancer or worsen their quality of life.

UW Veterinary Care is one of few veterinary specialty hospitals in the state of Wisconsin that provides state of the art care to pets with severe or complex illnesses and injuries. Clients often travel several hours to seek care from the Emergency and Critical Care, Surgery, Internal Medicine, Cardiology, Neurology, Ophthalmology, Oncology, Radiation Oncology, Special Species (exotics), Dermatology, Dentistry & Oral Surgery, Large Animal arge Animal Internal Medicine Services. A hospital closure would have detrimental effects on the health of companion and food animals beyond the city of Madison by delaying or limiting therapeutic options. Further, with the sharp increase in the number of pets requiring emergency care and hospitalization in the last year, many hospitals have had to turn patients away for hours or days at a time simply because they are full. A closure of our hospital would certainly increase the burden for other local or regional veterinary hospitals.

Finally, UW Veterinary Care is a teaching institution that is well known for providing a high quality veterinary medical education to its students. Interns, residents, faculty and staff are responsible for face-to-face teaching both in the laboratory setting (1st-3rd year) as well as in the clinical setting for fourth year students. Face-to-face instruction is essential for students to successfully complete this vigorous program and become competent veterinarians. Veterinary students have already faced delays in and modifications to instruction that may hinder their learning. A hospital closure has the potential to further impact our student's education in a negative way.

Veterinarians, veterinary technicians, and veterinary assistants have been working tirelessly throughout the COVID-19 pandemic, and due to the nature of our work, we are completely unable to socially distance in the workplace. Further, we have daily contact (although outdoors and masked) with the general public which increases our risk of exposure. A hospital closure due to COVID is a real possibility that could impact the health of pets statewide. I urge you to reconsider the addition of veterinary professionals to the Phase 1b vaccine distribution plan for the sake of all Wisconsin residents and their pets.
