





I write to comment on the exclusion from phase 1B of an important group of frontline healthcare workers—veterinarians, veterinary technicians and veterinary assistants. I believe this exclusion is a mistake that you should correct.


Animal healthcare providers have been designated as essential employees and thus have been working in close proximity to others who may be infected, just like human healthcare workers. Like their human healthcare counterparts, they have stood faithfully on the frontlines throughout the pandemic. By so doing, they have helped preserve the health and lives of animals that are important to our state's economy and in our lives in so many ways.

While this alone may be enough to ensure their inclusion in phase 1B, please consider another very urgent reason to do so. COVID-19 is a zoonotic disease, it is believed that it originally circulated in animals before jumping to humans, and as the DHS' own guidance points out, multiple outbreaks have been tied to sick animals on mink farms. In addition to risk of outbreaks, deadly new mutations that increase viral virulence or help to evade vaccines can arise within animal populations and remix to human populations.

Failing to inoculate as soon as possible this group that works with sick animals thus poses a biosecurity risk to the entire state and country as a potential source for transmission and a location where newly virulent viral mutations can occur.

As the mom of a veterinarian whose workplace on the University campus in Madison has seen multiple clusters of COVID-19 infected employees and also as a resident of Wisconsin, I want this group of essential workers included in phase 1B both because I want her protected and because I want the Department of Health to take this logical precaution that may help protect the entire state's population.

I urge you again to correct your mistake: please include this group of essential workers in Phase 1B of COVID-19 vaccinations.


