5. Specific Committee Items for Discussion (Public Comment)

- a. Drywall Program Low Enrollment (continued Discussion from Fall 2024)
 - i. The committee continued their discussion from the fall 2024 state advisory committee meeting where they discussed low enrollment in the drywall program. The committee said the reason for low enrollment is occurring mainly because local contractors don't want to pay wages to apprentices while they are not working and are instead at day school. Many contractors are just hiring people with prior drywall experience instead of sending new apprentices through the program to avoid this. The committee discussed perhaps going to the wage progression model used by other trades where PRI pay is built into the wage progression. Apprentices are paid an additional percentage towards their wages which can then go towards their related instruction costs/wages. Liz Pusch reminded the committee that compensation is a local committee item. Any proposed changes to the wage progression would first have to be discussed among the local committees The committee said they will bring this topic to the local committees for further discussion. It was mentioned that this item would most likely have to be changed within their CBA.

b. Wage Repayment Agreements

i. Liz Pusch provided an overview of recent concerns with sponsors and employers requiring apprentices to sign wage repayment agreements that could affect them in the instance of leaving employment with their assigned employer either within the course of their apprenticeship or after completion. Liz shared a memo that was issued in Feb 2024 outlining the statutory requirement of paid related instruction and the prohibition of requiring the repayment of contract-required PRI. The Advisory Council discussed this item at the February 2025 meeting and subsequently approved language for addition to the WI Apprenticeship Manual to clarify this. Notification will be provided when the Manual update is completed. Sponsors or employers can reach out to BAS for assistance in complying with this requirement, if needed.
