 - a) Heidi Sheire, Richland Center
 - i) Thank you. You are doing a great job.
 - ii) Husband is having cancer treatment. We need to thank our health care workers.
 - b) Dr. Malika Siker, Medical College of Wisconsin (MCW)
 - i) MCW has a four point strategic plan to address inclusion and diversity. Recruitment, inclusion, pipeline to jobs, and destination school for health careers.
 - ii) Want to get students there and then make sure they feel included once they get there.
 - iii) We want to collaborate with your group.
 - iv) Julie question: Is this just for physicians?
 - (1) Answer: No, all learners.
 - v) Lilliann question: What does success look like? Diversity looks different to different populations (1) Answer: We don't have a one size fits all metric.

 - i) There are several mentoring programs already in place. Lots of initiatives in the past have been successful.

 - i) Oral systemic link.
 - ii) Reduce medical dental silos.
 - iii) Using community dental health care coordinator positions to reduce dental ER visits and connect people with providers
 - e) Vincent Lyles, subcommittee member
 - i) We have CHWs at Advocate Aurora.
 - ii) Outcomes for the dental care coordinators seem similar to the CHWs. It would be good if the care coordinators (other names: CHWs, navigators, coaches) could navigate to the doctor or the dentist.
 - iii) Certification for CHWs may delay getting people into these positions.
 - f) Sandy Brekke, subcommittee member
 - i) I hear you on the CHWs. In Minnesota one concern is that the core class credits apply to other
 - ii) There is a CHW curriculum at the technical colleges, but they have not rolled it out yet due to lack of interest

- iii) Dental coordination is vital to bridging the gap.
- g) Dr. Sandra Underwood
 - i) CHW or similar positions have also been successful in the past. Cancer patient navigators are well developed, endorsed, integrated and reimbursed
 - ii) Many different types of CHWs now, but a lot of times there are no jobs for them after. Young people want to know if there are other trainings they can get later.
 - iii) There are schools that have associate degree programs for CHWs and then graduates go on get CNA degree and then later move on to more professional programs. So CHW is a pipeline.

 - i) Attended Health Careers Bridge Academy. Mentors, support, tools. Moved from CHW role to a different health care career.
