Provided information regarding Health Check other services (HCOS) options for county staff training to assist families in accessing HCO. The Division of Medicaid Services team working on improved access and use of HCOS has recently developed a communication bulletin for Medicaid providers that reiterates key elements of HCOS including information on access to HCOS services. The communication is currently out for industry review

Requesting the CLTS Council's input on communications related to HCOS with families; provider orientation; understanding of how the public can access waiver agency services. Council members expressed interest to discuss EPSDT transition more at the January 9, 2019, meeting.

BCS is preparing a survey for all CLTS waiver participants, mirroring the questions and format of current surveys issued to Birth to 3 families, focusing on public domain surveys with validated questions to gather information needed to inform program impact for families.

Survey findings will be shared with council, and recommendations for next steps will be reviewed as applicable.
