- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Dave Aldag in conformance with the Wisconsin open meeting laws.
- 2. Mr. Smith recorded attendance. A quorum was present.
- 3. The committee reviewed the current roster. No updates were necessary.

4. Actions

b. Review related instruction as part of the five-year cyclical review.

Nancy Nakkoul and Lynn Neitzel reviewed the objectives of the cyclical five-year review of related instruction: ensure the curriculum is current for industry needs, aligned with available youth apprentices, and aligned with other post-secondary education paths. They will survey the state committee through BAS and share the responses at the 2023 spring meeting.

5. Discussions

a. Follow-up questions regarding the BAS Director's Call with State Committees Attendees did not have questions or comments.

b. How well is the current training working?

Owen Smith reviewed that the streamlined format of state committee meetings focuses nearly entirely on training policies and content specific to the committee. He inquired if the on-the-job learning needed to be reviewed or updated to meet current training needs.

The state committee advised that no updates are needed at this time.

c. How is industry preparing for potential infrastructure funding?

The state committee reported that the industry continues to develop pipelines for qualified applicants through general outreach, youth apprenticeship, and certified pre-apprenticeship.

Attendees asked when the funding or projects will be announced. Director Polk replied that the Bureau does not know.

d. Reimbursement for on-the-job learning and supportive services

Director Polk reviewed the flier in the meeting material and noted that reimbursement is not contingent upon wage.

The state committee asked how much funding remained. Director Polk replied that sufficient funding remains, so he encouraged the state committee to inform employers and apprentices.

The state committee inquired into the deadline. Director Polk replied that the deadline is July 1, 2023, or when funds expire.

e. Register your National Apprenticeship Week event

Director Polk reviewed the website and encouraged attendees to host events and register them through the Department of Labor.

Attendees did not have questions or comments.

- 7. The meeting adjourned at 11:45 a.m. The Bureau will schedule the next meeting via electronic survey.
