Phil Koenig updated the committee on the ETPL policy work. Staff met with the WWDA and will have another meeting with the WWDA in February or March to work on details of the policy. The ETPL policy will be completed in the Spring.

Tom Pethan presented the analysis on proposed planning regions. The purpose of identifying regions is to align workforce development activities and resources with larger regional economic development areas and available resources to provide coordinated and efficient services to both job seekers and employers. Based on the required WIOA planning criteria the following planning regions were proposed:

- Southeast, Milwaukee, and WOW WDAs
 - Exclusively share an economic development region
 - Collectively have the strongest commuting ties

- Fox Valley and Bay Area WDAs
 - Almost exclusively share an economic development region
 - Strong commuting ties
 - Similar industry shares across the board

Mark Tyler asked if the research took into consideration commuting across state lines (e.g. Duluth/Superior). Phil Koenig stated that now the research focused on regions within Wisconsin.

Lisa Hebgen asked about the timeline for moving forward with Regional Planning. Phil Koenig stated that Tom Pethan will present the information to the full Council in April and that DET will be working with the CEOs and WDBs in April or May on the process. DWD received a Technical Assistance Grant from DOL to work on the process. The grant ends in June 2018.

The committee agreed the proposed regions should move forward.
