





Representation / Decision Making Power / Access

"A disconnected or misguided government, legislative, donor, corporate, and philanthropic community that denies or lacks understanding of the root causes of poor health and inequities, racial or otherwise, and who make decisions that do not support or advance Black women, families and community"

"Representation & Inclusion politics, "A Seat at the table" when the table is anti-Black"



Representation / Decision Making Power / Access

"Efforts that increase access to policymakers and policy-making efforts can support and can shift relationships and lead to increased access to opportunity."

"Strong culture of "co-designing" solutions to community problems with the people who are directly impacted;"

Structural Funding Inequities

• Safety Net Pitfalls

"Holistic policies that address the whole child and whole family in terms of health, education, employment, and social supports regardless of which program they are enrolled in would better support all children and families in the state.

Right now efforts across programs are too siloed and dependent upon criteria laid out in various funding streams or statutory provisions.

Kids and families are dynamic but our policies and programs do not often reflect that."



Structural Funding Inequities

• Medicaid/Badger Care Expansion

"Polices like Medicaid/BadgerCare expansion, Healthy Women, Healthy Babies, Paid leave, expansion of postpartum Medicaid coverage to 12 months"

"Changing State income limit, so that every household can have health insurance."

"Ensuring that WI residents regardless of immigration status are able to access support and funds"



Structural Funding Inequities

• Misalignment of State and Local Funding

"Some of the county run programs like our mental health programs have limited budgets. We are a poor county, so we have to ration health services."

Opportunity: "federal grants such as the Preschool Development Grant (PDG) which bring money into the state to help children and family's birth through five and does not require approval from the legislature on how funds will be spent."



Structural Funding Inequities

Access to Healthy Food

"more access to alcohol than fresh fruit and vegetables"

"investments that result in additional consumption of unhealthy food"

"Federal Head Start Performance Standards support children birth to five to be connected with....nutritious meals and snacks " and our city supports things like our farmer's markets and EBT dollars so that ALL persons have . "

Investment in Targeted Programming for Under-Resourced Communities "There is a need for funding and resources that could aid Black youth who intend to engage in communal social justice.

Youth who want to organize things for themselves and their communities to attend.

There are a lot of young people who want to have events, programs, etc. for themselves but have to beg for money and resources."

"Several youth in the youth justice system have underlying mental and behavioral health issues that require treatment. A lack of program options as well as a lack of access to existing programs often means that many children who should not be interacting with the youth justice system end up doing so because the appropriate services they need do not exist."



Investment in Targeted Programming for Under-Resourced Communities "A community wide Language Access Strategy is needed desperately needed...

There is a big asterisk behind everything we do that says "if you speak English" Our Somali, Latino and Hmong communities are growing and to not have equitable language access disempowers people and prevents them from achieving optimal health and wellbeing."




Executive Order:

"The purpose of the council is to address the various factors that exacerbate health disparities by creating a comprehensive plan to achieve long-lasting and equitable health outcomes for all Wisconsinites.

The plan will address health disparities based on race, economic status, education level, history of incarceration, and geographic location." - DHS Website


The Governor's Health Equity Council shall develop a plan, supported by a body of research, with key benchmarks to reduce and eliminate health disparities throughout the State of Wisconsin by 2030. The plan shall address health disparities in populations based on race, economic status, education level, history of incarceration, and geographic location. The Health Equity Council may create such subcommittees as are necessary to achieve this mission.

 - We are not able to guarantee everyone will be assigned their top choice








