- ACS NTDS Data Dictionary
 - ◆ No retired elements
 - ◆ No new elements
 - ◆ No major current element changes
 - ◆ No inclusion criteria changes

2024 Data Dictionary: Wisconsin Changes

- ◆ Required for State Direct Entry Submissions
 - TR25.33 Hospital admission date
 - TR25.47 Hospital admission time

2024 Data Dictionary: Wisconsin Changes

- ◆ Required for all (currently required for direct entry)
 - TR33.1 Referring facility
 - TR8.8 Mode of arrival
 - TR17.25 ED discharge date
 - TR17.26 ED discharge time
 - TR25.34 Hospital discharge date
 - TR25.48 Hospital discharge time

2024 Data Dictionary: Wisconsin Changes

- ◆ New optional data element
 - TR29.10 Safety equipment devices
 - Linked to TR29.24 Protective Devices
 - Appears when “Other” is selected
 - Free text field

2024 Data Dictionary: Wisconsin Changes

- ◆ Change from required to optional for direct entry
 - TR33.2 Referring facility arrival date
 - TR33.3 Referring facility arrival time
 - TR33.30 Referring hospital discharge date
 - TR33.31 Referring hospital discharge time

2024 Data Dictionary: Wisconsin Changes

- ◆ Change from required to optional for direct entry
 - TR5.33 Extrication
 - TR7.3 Name of EMS service
 - TR15.38 EMS run sheet/status
 - TR17.78.3 New activation level

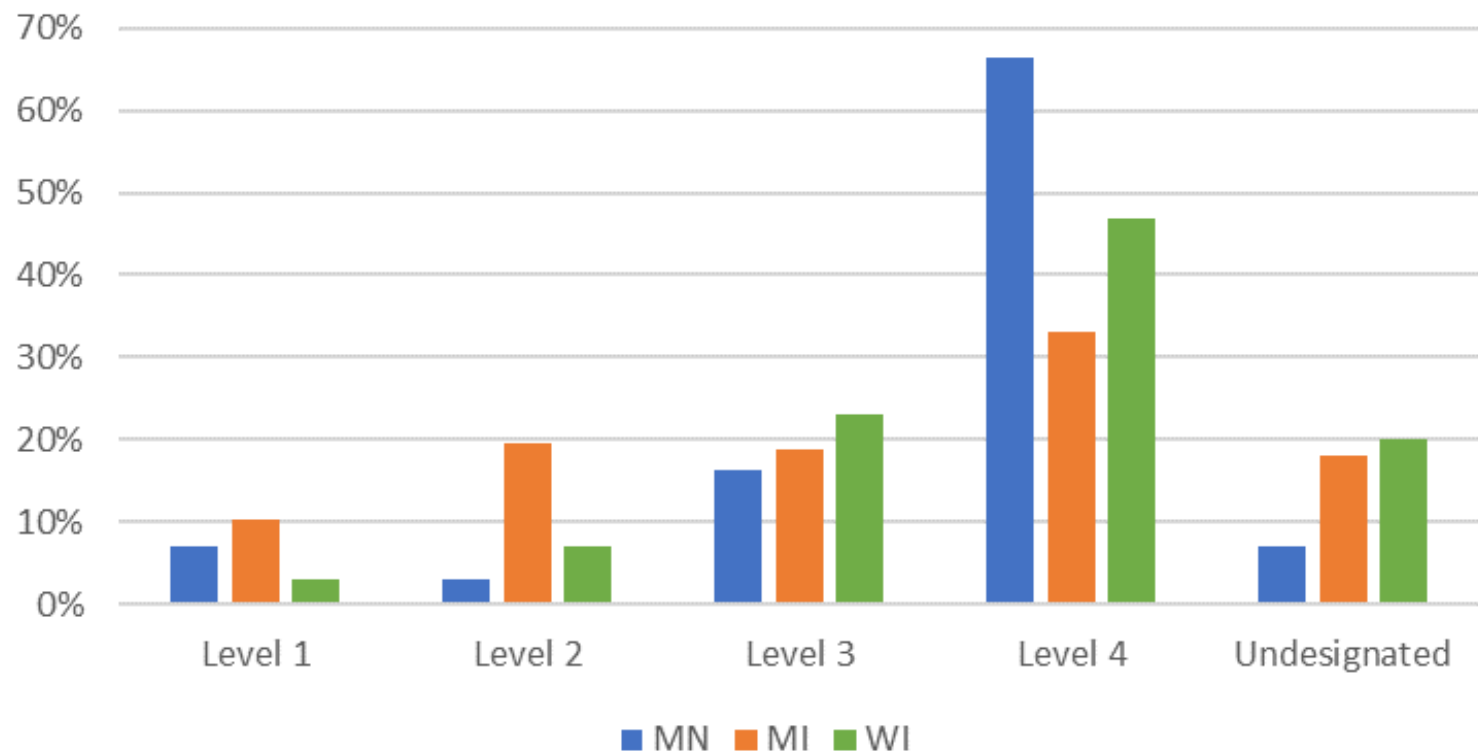
