- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Pat Rodriguez, in conformance with the Wisconsin Open Meetings Law.
- 2. A roll call was conducted. A quorum was present.

#### 3. Old Business

a. The committee reviewed the current roster.

b. The committee approved the minutes as revised: Scott Panek is not a member; Brandon Neddef was present.

c. Director Polk and Mr. Smith discussed the committee's request to expand its membership. Director Polk stated that the Bureau will expand the committee only when the balances of labor and management and union and non-union employer members is skewed noticeably. The Bureau reported that the roster is balanced and ensures meaningful participation from all parties.

## 4. New Business

## a. Review the revised template for state standards.

Mr. Smith discussed the three objectives of revising the state standards: incorporate the revised content and terms from the *Wisconsin Apprenticeship Manual*; incorporate updated policies from the Department of Labor; and cite policies as established by the *Manual* or the state committee.

Mr. Smith explained that the revised table of contents reflects the operational scope of state committees: they establish minimum standards but are not parties to the apprentice contract. Section one included policies for state committees established in the *Manual;* section two included policies established by the state committee itself. Policies that pertain to sponsors, such as evaluating and completing apprentices, were omitted; they will be addressed in the revised template for sponsors.

The state committee asked for guidance on the Department of Labor policy that permits applicants to be either a U.S. citizen or an eligible non-citizen. Mr. Smith replied that the Bureau is awaiting guidance and best practices from the Department of Labor.

#### b. For action: verify policies established by the state committee.

Mr. Smith asked the committee to verify that its policies were successfully transferred from the old template to the new template.

Action: the committee verified its previous policies were included in the new template; and it updated the list of organizations that nominate employee and employer members.

c. Action: identify policies established by the state committee to revise further in fall, if needed. Next, Mr. Smith asked the committee to identify previous policies that it that may warrant further discussion at the fall meeting.

Action: The committee recommended reviewing these policies at the next meeting:

- Applicants must be physically fit and able to perform the tasks of the trade with or without reasonable accommodation.
- Minimum qualifications for employers
- Requirements for supervision
- Schedule of work processes (Exhibit A)
- Requirements unique to the occupation

## d. Questions from the Director's Call.

Mr. Smith reminded the committee that the Bureau will share apprenticeship-wide updates on the Directors' Call so each committee's individual meeting will be dedicated to its unique policies. However, the Bureau will include this topic on each agenda to ensure committees have an opportunity to ask follow-up questions, if needed.

Attendees did not have questions or comments.

## e. Communicating state committee meetings to the public

Mr. Smith reported that he will discontinue cc'ing non-members on courtesy notifications of state committee meetings for appointed members. He reminded attendees that state committee meetings are open to the public and posted publicly; however, some stakeholders have confused the courtesy notification as permission to attend. He will continue emailing a courtesy meeting invitation to appointed members, who are welcome to forward it to colleagues. Non-members must check the websites.

Attendees did not have questions or comments.

#### f. Other

Attendees did not have additional questions or comments.

## 6. Review the program participants.

Director Polk congratulated the state committee on contributing to Wisconsin Apprenticeship surpassing 15,000 apprentices for the second time in its history.

The state committee did not have questions or comments regarding the reports.

7. The meeting adjourned at 11:35 a.m. The Bureau will schedule the next meeting via electronic survey.


