**b. DSPS Exam Process** (moved to DSPS Updates)

**c. Ratio Neutral Language**

BAS presented a proposed change to the State standards as follows. *"Apprentices in their 5<sup>th</sup> year who have completed all requirements of their apprentice contract with the exception of the 54-hour Plumbing Review Course or passing the test-out option and passing the State Plumbing Journey Worker Exam will not be counted as apprentices or journeyworkers for the purpose of the apprentice to journeyworker ratio."*

Committee discussion about concerns with proposed language, specifically the change to completing all OJL hours before becoming ratio neutral. BAS explained that the ratio neutral language is only applicable to the licensed trades to allow for additional exam time. The committee would like to propose a minimum amount of OJL hours to be added to the new language. The topic was tabled to allow further discussion with local committees. A special meeting will be held virtually in early to mid-November for one-hour to resolve this topic. BAS will send a poll for the meeting time.

**d. Mental Health Training for Apprentices**

Committee discussion about possibly adding additional mental health training into the Transition to Trainer curriculum and/or requiring the optional 2-hour OSHA mental health training in their program in the first year. A Council sub-committee meeting, including WTCS, will be held on 10/12/2025 for this topic.

## 7. WTCS Report

- Dean Peterson from Madison College reported that he has been working with WIDS and Mandy Mayek in a sub-committee to evaluate Green Plumbing curriculum. They will do a report out to the committee when complete.

## 8. DSPS Updates

### a. Plumbing Code Book Supervision Language

BAS asked to table this issue. The code book language doesn't match what is in the State Standards. A sub-committee was created to address this issue. Members to include Christina Breitlow, Dave Kozinski, Dan Callies and Andy Wagner.

### b. DSPS Exam Process

Committee members reported that the previously reported scaling question was corrected on the Pearson Vue exam. The apprentice who challenged a question also had their issue addressed and was passed.

### c. Other updates

DSPS "Application for Pre-Determination" form #3085 is active. Applicants and/or existing apprentices can utilize the form to find out if they will qualify for future licensing. Fee is \$68.00 and will be credited toward their next credential fee in the same occupation. BAS will inquire if the field in LicensE where apprentice contracts are uploaded can be made mandatory in their system to reduce credential application delays. LicensE application status meanings were shared. *Pending Applicant Input* indicates the applicant needs to submit additional documentation and/or information. *With DPCP Staff* indicates no action is required from applicant.

**a. Ratio Neutral Language**

- i. BAS shared the proposed ratio neutral language revision to the Plumbing State Standards discussed at the fall committee meeting. Joe Brenner shared opposing feedback from several local committees and contractors. Their concern was with the reference to "... who have completed all requirements of their apprentice contract". He proposed replacing that language with "who are in good standing" and to have that managed by the individual local committees.

Additional discussion about removing the specific details of the exceptions to allow for future revisions to the program without the need to revise standards. Language proposed was "trade-specific DSPS requirements" which is to include 54-hour Plumbing Review Course or passing the test-out option, successful passing the State Plumbing Journey Worker Exam, and Transition to Trainer

- ii. Committee voted to add the following language to their standards as follows: ***Apprentices in their 5<sup>th</sup> year who are in good standing with the exception of completion of the trade-specific DSPS requirements will not be counted as apprentices or journeyworkers for the purpose of the apprentice to journeyworker ratio.***
