- 1. Call Adult Quality Committee Meeting to Order......Kristin Welch/Lynn Harrigan
  - a. Welcome and Introductions
    - Denise Eder joined us to sit in on the meeting. Lead for the recovery and wellness consortium (western region) provide CCS to 9 counties; a lot of TA and training for the county staff on CCS statute and Medicaid

- ii. Some areas of key outcomes that we might look at.
- iii. Talked about setting up zoom meetings for June 16<sup>th</sup>, June 30<sup>th</sup>, and July 14 with reps from county association and Medicaid. Talk about how Medicaid is used in other states (MN) and other presenters that could give us a lens on block grant fund utilization and how to prevent cases from going to the institutions. And also finding money for staff in the Bureau considering we have 4000 staff in the institutions.
- iv. Lynn agrees that Winnebago cases are rising for people who may not be appropriate.
- d. Mental Health Block Grant Presentation by Mental Health Planner, Maddie Johnson
  - i. Question on more specific outcomes because the MHBG report is not very detailed.
  - ii. The State itself takes on the responsibility of tracking outcomes vs actually reporting it to the federal government.
  - iii. Rick mentioned that he would be interested in hearing more of the nitty gritty of each topic item that the state works on. Rick is concerned about the accessibility of CSC (Coordinated Specialty Care) to non-populated counties (so counties other than Dane and Milwaukee)
  - iv. Lynn stated that we need to place more emphasis on outcomes to discover if the money we are spending is working. This will help us improve tracking and to promote future funding opportunities for mental health funding.
  - v. MHBG is unable to fund population-level prevention; FEP isn't considered prevention since it's a service being provided after a youth starts exhibiting psychosis symptoms.
  - vi. Implementation for zero suicide can be disappointing as a lot of activities are non-reimbursable.
  - vii. Referred to the URS report about where the money goes for the MHBG.
  - viii. AQC can take a look at the upcoming 2020 URS report

## f. Off agenda:

- i. Block grant considerations:
  - What is the response to the need for funding and other state models?
    - a. Sheryl: us as a council have more influence over how the block grant monies are constructed and paid out than we do over any type of political influence on the state budget is constituted.
      - i. Maybe we need to put our emphasis on the construction of the block grant.
    - b. Have an arm of the mental health council who looks at the budget (leg and pol). Would agree that the block grant is somewhere where we have some expertise where we can bring to the table and is not duplicative of another group.
    - c. If we aren't able to influence through the political process, then we should try to push where we can influence.
  - Only funding for one position with no support, and this doesn't work to improve outcomes.
  - Especially for tribes without CCS. How do we fund these programs?
  - Could use FNMWC for tribes who need help for CST funding.
  - Zero suicide model; talks about it not being culturally relevant for indigenous people. So how can we make that happen?
  - CST is such a great model but it's not a funding source. It's a wraparound model but there's no funding attached.
  - Indicators for wellness did not match for indigenous people. Is this the same for zero suicide?
- ii. Dawn: interested in these models being culturally relevant; socio-cultural lens because culture is SO important.
- iii. Accountability to organizations; is this being measured and how?
- iv. Would love to see for tribal communities in urban areas to have training on that FNMWCF Model
- v. Rick: holistically, the FQHCs, almost all tribal clinics have FQHCs. Question is; with flexible funding through FQHC, is there a component with intervention and prevention that is holistically oriented? Kristin will get back to him on that, but in Menominee it was happening.
- vi. Because this worked in Milwaukee at 16<sup>th</sup> street (based on Rick's assessment)
  - Dawn; can't speak about all of the FQHCs, but they do know MHS and 16<sup>th</sup> st clinic do good job in that area. The geral ignatious (sp?) center is more indigenous focused.
- vii. Asking because with the smaller pool of block grant funding, doesn't leave much flexible money. However, there are instances in the SUD side where FQHCs have benefited. Hub and spoke model has been used for flexible MA funding.
- viii. Would be good to invite these FQHCs to the zoom meetings.
