- 1. The meeting was called to order at 10:03 a.m. by Tracey Griffith, Committee Co-Chair, in conformance with the Wisconsin open meeting laws.
- 2. Mr. Owen Smith recorded attendance. A quorum was present.
- 3. Action: the state committee will elect the Employee Co-Chair at the 2023 spring meeting.
- 4. **Action:** the state committee approved the minutes as written.

#### 5. Discussions

#### a. Follow-up questions regarding agenda items from the Directors' Call

The state committee did not have questions or comments regarding the Directors' Call.

**b.** Should sponsors enter Transition to Trainer, Related Instruction completion dates in BASERs? Mr. Smith reviewed that the state committee requested to discuss this item.

Mr. Wiatt advocated for sponsors entering completion dates into BASERS because it would streamline a large quantity of data entry. He explained that his local committee teaches Transition to Trainer on-site; therefore, he notifies the Apprenticeship Training Representative.

Deputy Director Pusch thanked Mr. Wiatt. She noted that local committees for most construction occupations send apprentices to the technical college system for related instruction and Transition to Trainer, which requires a certain procedure for processing completions. However, Mrs. Pusch noted that the construction craft laborer joint apprenticeship committees teach both related instruction and Transition to Trainer in-house. Therefore, she is willing to consider alternate arrangements for processing the completions.

## c. Reimbursements for on-the-job learning and supportive services

Director Polk reviewed the flier included in the meeting material.

Co-Chair Griffith reported that her organization found the process very easy. She encouraged other employers to pursue the reimbursements.

## d. Revising the outline of work processes

Mr. Smith recommended that the state committee review its work processes to ensure they reflect current training and are written clearly. He reported that he helped several construction occupations update their work processes recently, and their state committees found the process very helpful.

The state committee agreed and recommended that a focus group create a first draft. Volunteers included Leigh Emrick, Ray Wiatt, and Tracey Griffith.

#### e. Other

Director Polk asked the state committee how its industry may prepare for potential federal funding for infrastructure projects.

The state committee replied that the industry continues to focus significantly on recruiting women and minorities. Infrastructure projects have not been announced but the industry anticipates an more road building and repair and broadband installation. Mr. Wiatt reported that a small percentage of apprentices continue to experience difficulties signing their apprentice contract due to personal issues or technical issues. As local committees hire more apprentice, that small percentage might increase.

Co-Chair Griffith agreed: some apprentices don't believe its important; others experience technical issues.

The committee and Deputy Director Push agreed that he local committees and employers are responsible for remediating the apprentices.

#### 6. Review the program participants.

The state committee did not identify discrepancies in the data. A general discussion followed on the increase in applicants across local committees.

7. The state committee adjourned at 11:00 a.m. The Bureau will schedule the next meeting via online survey.


