

The hearing will provide all parties and individuals interested in the proposed cooperative boundary plan with an opportunity to be heard. The Department will make no decisions at the hearing.

Stats. Furthermore, participants are also invited to consider the comments of any preceding speaker to avoid unnecessary and time-consuming duplication of information. Comments may also be submitted to the Department prior to the hearing, as well as within 10 days following the hearing, which is Friday, February 21, 2020.
