- 1. The meeting was called to order at 10:03 a.m. by Co-Chair Dave Aldag in conformance with the Wisconsin open meeting laws.
- 2. Mr. Smith recorded attendees as they introduced themselves. A quorum was present.

## 3. Old Business

#### a. Review the roster.

The committee reviewed the roster. Dajen reported her organization's nominee, Rob Weise, is not included; Scott Knocke reported that he will nominate individuals to fill the vacancies on the labor side; and the committee will elect the Employee Co-Chair at the fall meeting.

## b. Action: approve the minutes.

The committee approved the minutes as revised: a contractor's company was listed incorrectly.

## 4. New Business

## a. Review the revised template for state standards.

Mr. Smith discussed the three objectives of revising the state standards: incorporate the revised content and terms from the Wisconsin Apprenticeship Manual; incorporate updated policies from the Department of Labor; and cite policies as established by the Manual or the state committee.

Mr. Smith explained that the revised table of contents reflects the operational scope of state committees: they establish minimum standards but are not parties to the apprentice contract. Section one included policies for state committees established in the Manual; section two included policies established by the state committee itself.

Policies that pertain to sponsors, such as evaluating and completing apprentices, were omitted; they will be addressed in the revised template for sponsors.

Several members of the state committee expressed concern that the standards had been revised without involvement of the committee. A general discussion followed about the various sources of policy included in the standards and the review process to date. Mr. Smith and Director Polk emphasized that the revisions included administratively required language from The Manual, the revisions were approved by the Wisconsin Apprenticeship Advisory Council, and the policies established by the committee had not changed. The members contested that they were not included in the Council's discussion.

Mr. Smith reiterated that he needed the committee to take two actions: verify that its policies were included in the revised template; and identify policies that it established that may warrant further discussion in the fall.

The state committee reported that it was not prepared to take action at this meeting. The committee recommended taking additional time to review the template and meeting again for a vote. The Bureau recommended meeting in early May to ensure the Bureau can implement the template.

Action: The committee and BAS agreed to table the action items and reschedule.

**b.** For action: verify policies established by the state committee. This item was tabled.

c. Action: identify policies established by the state committee to revise further in fall, if needed. This item was tabled.

## d. Questions from the Director's Call.

Mr. Smith reminded the committee that the Bureau will share apprenticeship-wide updates on the Directors' Call so each committee's individual meeting will be dedicated to its unique policies. However, the Bureau will include this topic on each agenda to ensure committees have an opportunity to ask follow-up questions, if needed.

Attendees did not have questions or comments.

#### e. Communicating state committee meetings to the public

Mr. Smith reported that he will discontinue cc'ing non-members on courtesy notifications of state committee meetings for appointed members. He reminded attendees that state committee meetings are open to the public and posted publicly; however, some stakeholders have confused the courtesy notification as permission to attend. He will continue emailing a courtesy meeting invitation to appointed members, who are welcome to forward it to colleagues. Non-members must check the websites.

Several members requested the Bureau consider implementing a notification system or other means of alerting non-members when meeting material is available.

## f. Other

Attendees did not have questions or comments.

7. The meeting adjourned at 11:25 a.m. The Bureau will schedule the next meeting via electronic survey.
