The Commission approved the Report to the Legislature on Wisconsin Holding Companies for the year of 2025 and directed the Division of Energy Regulation and Analysis to submit the report to the Legislature.

1-AC-259 - Proposed Revision of Wisconsin Administrative Code Chapter PSC 114 as Wisconsin State Electrical Code, Volume I for NESC 2023

Appointment of Advisory Committee Members

The Commission approved the proposed roster update for the Wis. Admin. Code ch. PSC 114 Advisory Committee and directed Commission staff to draft correspondence confirming committee appointments.

9597-TI-103 - Investigation into Q Link Wireless LLC's Status as an Eligible Telecommunications Carrier

The Commission directed that a Notice of Proceeding and Notice of Proposed Recission regarding Q Link LLC's Eligible Telecommunications Carrier(ETC) designation be issued. If no comments on the notice are received the Commission Secretary is directed to sign an order revoking Q Link LLC's ETC Certification and to refer the matter to the Wisconsin Department of Justice for further proceedings.

3270-TE-120 - Application of Madison Gas and Electric Company for Approval of a Commercial Electric Vehicle Charging Allowance Pilot Program Tariff

The Commission reviewed the application of Madison Gas and Electric Company (applicant) for approval of a Commercial Vehicle Charging Allowance (CVCA) Pilot Program Tariff and approved the application as filed with the following conditions:

1. The applicant shall submit an annual report once the CVCA Pilot Program is operational that includes the following non-exhaustive list of items:
 - a. The total number of projects under the program;
 - b. Capacity and type of charging station at each site;
 - c. The type of application for each charger (whether that be for public use or a private fleet, for example);
 - d. Total incentives paid out and total being held back;
 - e. Status of all ongoing projects;
 - f. the number of pre-applications received;
 - g. the number of pre-applications denied, and the reasons for denial;
 - h. the total number of unique, individual customers served;
 - i. total MWh sold associated with the tariff;
 - j. Marketing and information materials to Commission staff for review and suggested modifications prior to launching the program;
 - k. Additional metrics based on the applicant's working with staff to ensure that costs and benefits are tracked accurately and completely and to identify clear cost-

benefit calculations and reporting metrics, including a clear timeline on when the benefits are expected to be realized.

2. The applicant shall work with Commission staff to determine what, if any, waivers are needed; and the decision of whether or not to grant one or more needed waivers shall be delegated to the Division Administrator of the Division of Digital Access, Consumer, and Environmental Affairs with the advice and consent of the Division Administrator of the Division of Energy Regulation and Analysis.
3. The applicant's proposed accounting treatment as proposed is approved with all the following conditions:
 - a. The authorization is for accounting purposes only and does not bind the Commission to any specific treatment for this item in any future proceeding involving the applicant's rates or other matters before the Commission; and
 - b. The Commission shall have full access to all books and records related to the expenditures associated with the CVCA Pilot Program.
4. As part of the rate case where the recovery of the deferral is considered, the applicant shall present options for programmatic cost assignment for Commission consideration, and one of those options shall include a direct assignment of costs to participating customers.
5. In a future rate case, the applicant shall provide substantive information demonstrating the benefits of the CVCA Pilot Program, which includes cost-benefit analyses and a discussion of system-wide and public interest benefits
6. The Commission accepted the applicant's proposal to close the EV-4 pilot rider.

The Commission directed the Division of Energy Regulation and Analysis to draft an order consistent with its discussion. The draft final decision shall be returned to the Commission for final approval.

3560-TE-107 - Application of City of Menasha, as an Electric Public Utility, Calumet and Winnebago Counties, Wisconsin, for Approval of a Project Share Program Tariff

The Commission approved Menasha Utilities' application of its proposed Project Share Program Tariff.

The Commission directed the Division of Digital Access, Environmental and Consumer Affairs to draft an order consistent with its discussion.
