Updates:

HEDI Charges

- 1. Oversee the implementation of the Equity and Inclusion Plan.
- 2. Meet requirements of affirmative action under Chapter 230 by:
 - Advising the secretary concerning programs designed to ensure equal opportunity to all employees, applicants and clients.
- 3. Select (3) budget proposals from non-committee members for consideration by Secretary's Office for inclusion in DHS budget.
- 4. Select (3) items related to DEI for the committee to analyze and review to provide formal and direct recommendations or materials to DHS.
- 5. Support education and training on diversity, equity, and inclusion by:
 - a. Identifying trainings for executives management and all staff.
 - b. Recommending trainings and resources for external stakeholders.

Budget Celebrations

Passed and signed provisions with an equity focus

Community Health Centers and Free and Charitable Clinics

Increases funding by \$2 million for Community Health Centers and Free and Charitable Clinics.

Long-term Care Workers

- Increases funding for direct care workforce serving individuals in the Family Care program by \$104 million.
- Increases funding for Medicaid personal care rates by over \$78 million.

Lead Safe Homes

Continues ongoing funding of \$28.4 million for Lead Safe Homes program for CHIP-eligible households within the Medicaid budget.

Behavioral Health Crisis Services

Provides for \$10 million to establish regional crisis systems.

Dementia Care Services

Provides \$3.5 million in funding dementia care specialists (additional 18 for counties and 7 for Tribal nations) to ensure staffing across the state.

Tribal Care Coordination Agreements

- Authorizes Tribal nations to use care coordination agreements.
- Increases federal funding by \$5.5 million.
- Provides GPR payments for costs that are shifted to federal funding.

Home and Community Based Services – ARPA process

- ARPA provides Enhanced Federal Matching Percentage for Medicaid-eligible activities
 - Approximately \$350 million allocated for Wisconsin
 - Centers for Medicare and Medicaid issued guidance (examples of qualifying activities)
 - DHS engaged in stakeholder outreach
